

**To: All holders of an electricity generation licence**

**Electricity Act 1989  
Section 11A(1)(b)**

**Modification of the standard conditions of all electricity generation licences**

1. Each of the licensees to whom this document is addressed has a generation licence which has been granted or treated as granted under section 6(1)(a) of the Electricity Act 1989 ('the Act').
2. Under section 11A(2) of the Act the Gas and Electricity Markets Authority ('the Authority')<sup>1</sup> gave notice on 24 March 2015 ('the Notice') that we propose to modify standard condition ("SLC") 14 (Compulsory Acquisition of Land etc.) and SLC 15 (Other powers etc.) of the generation licence. We stated that any representations to the modification proposal must be made on or before 19 May 2015.<sup>2</sup>
3. A copy of the Notice was sent to the Secretary of State in accordance with section 11A(4)(b) of the Act, and we have not received a direction that the change should not be made.
4. We received 5 responses to the Notice, which we carefully considered. We have placed all non-confidential responses on our website. Our response to these comments is set out in the accompanying letter.
5. It is necessary to make a number of minor alterations to the modifications set out in the Notice. The reasons for any differences between the modifications set out in the Notice and the modifications reflected in Schedule 1 are to address concerns raised in consultation responses and to clarify the drafting as follows:
  - A respondent believed that the reference in proposed modification SLC 15(4)(b) to "including, for the avoidance of doubt, works preliminary to those activities" is confusing and questioned whether the works under paragraph 10 Schedule 4 would be anything else. On reviewing SLC 15 further, we agree that the wording "works preliminary to those activities" causes a degree of circularity because the preliminary works that a licensee could undertake under paragraph 10 of Schedule 4 are only entering land to survey. Therefore, we have removed this wording to clarify the drafting.
  - By the insertion of the words "including, for the avoidance of doubt, works preliminary to those activities" in proposed SLC 14(2)(c) and 15(2)(c), a respondent was unclear as to how Schedules 3 and 4 are to apply to works preliminary to the rest of the items in the lists in SLC 14(2) and 15(2). On reviewing SLC 15 further, we note that the wording "works preliminary to those activities" causes this confusion because of its circularity. The preliminary works that a licensee could undertake for all of the items in SLC 14(2) and SLC 15(2) (subject to 15(3) and (4)) are set out in schedules 3 and 4 respectively. For example, the preliminary works under Schedule 3 would involve acquisition of land or rights over land pursuant to a compulsory purchase order and the preliminary works under Schedule 4 could cover obtaining wayleaves and other consents provided for under Schedule 4. Therefore, we have removed this wording to clarify the drafting.

- We have also included the words 'in sub-paragraph (c)' in SLC 14(2)(c) and 15(2)(c) to clarify application of this provision.
  - In SLC 15(3), we have inserted the words "and sub-paragraph (b) of paragraph 4 below" to provide clearer cross-referencing to the meaning of the reference to electric lines in SLC 15(4)(b) including when electric lines have the extended meaning relating to pipes conveying heat.
  - The words "and/or" have been inserted into SLC 15(2) for consistency with SLC 14(2) and clarity of drafting.
6. We are making these licence changes because we believe that the issues identified could in practice cause delay and/or higher costs in developing or connecting generation, and be a source of uncertainty for stakeholders. This could, in particular, restrict the development of offshore generation. Given this and following consideration of all responses as discussed in our accompanying letter and in our previous consultations, we have decided to make the licence modifications. We consider that the licence amendments provide certainty for licence holders and other stakeholders and facilitate timely and efficient development of all electricity generation, including the connection of offshore generation to the onshore transmission system.
7. The effect of the modification(s) will be to:
- with Authority consent, enable access to the compulsory entry power for generators seeking to survey the suitability of land for electric line activity including the installation, inspection, maintenance, adjustment, repair, alteration, replacement or removal of electric lines and electrical plant associated with them and any structures for housing or covering such lines or plant, connecting a generating station with the national electricity system or distribution system;
  - clarify that the provision of compulsory powers for generators accessed for the purposes of electric line activity are exercisable whether that electric line activity is carried out by the licensee or another licence holder; and
  - remove inconsistency between SLC 14 and SLC 15 in the description of the types of activities covered.
8. Where an application for permission to appeal our decision is made to the Competition and Markets Authority (CMA) under section 11C of the Act, Rule 5.7 of the CMA's Energy Licence Modification Appeals Rules<sup>3</sup> requires that the appellant must send to any relevant licence holders who are not parties to the appeal a non-confidential notice setting out the matters required in Rule 5.2. The attached Schedule 2 provides a list of the relevant licence holders in relation to this modification. Section 11A(10) of the Act sets out the meaning of 'relevant licence holder'.

Under the powers set out in section 11A(1)(b) of the Act, we hereby modify the standard licence conditions for all electricity generation licences in the manner specified in attached Schedule 1. This decision will take effect from 23 October 2015.

## Schedule 1: Licence Drafting

### MODIFICATION OF THE STANDARD CONDITIONS OF THE ELECTRICITY GENERATION LICENCE

Standard conditions 14 and 15 of the electricity generation licence are modified in the manner set out in this schedule. The insertions are shown underlined and deletions are shown cross-through.

#### Condition 14. Compulsory Acquisition of Land etc.

1. This condition shall have effect and come into operation for the purpose of this licence on and from 1 May 2007.

2. The powers and rights conferred by or under the provisions of Schedule 3 to the Act (Compulsory Acquisition of Land etc. by Licence Holders) shall have effect in relation to the licensee to enable the licensee to carry on the activities authorised by this licence and which relate to:

- (a) the construction or extension of a generating station;
- (b) ~~activities connected with the construction or extension of a generating station or connected with the operation of a generating station; and/or~~
- (c) the installation, inspection, maintenance, ~~removal or~~ adjustment, repair, alteration, replacement or removal of electric lines and electrical plant associated with them; and any structures for housing or covering such lines or plant, connecting a generating station with:
  - (i) the national electricity transmission system; or
  - (ii) a distribution system.

including, for the avoidance of doubt, whether these activities in sub-paragraph (c) are to be carried out by the licensee or another licence holder.

3. In paragraph 2 above:

- (a) the references to "generating station" are to an electricity generating station which:
  - (i) has, or will have when its construction or extension is completed, a capacity of not less than 50 megawatts or such other capacity as may be specified in relation thereto by order of the Secretary of State under section 36(3) of the Act; and
  - (ii) is, or will be when its extension or construction is completed, operated by or for the licensee; ~~and~~
- (b) "extension" in relation to a generating station includes the use by the person operating the station of any land (wherever situated) for a purpose directly related to the generation of electricity by that station.

## Condition 15. Other powers etc.

1. This condition shall have effect and come into operation for the purpose of this licence on and from 1 May 2007.

2. The powers and rights conferred by or under the provisions of Schedule 4 to the Act (Other Powers etc. of Licence Holders) shall, subject to paragraph 3 and 4 below, have effect to enable the licensee to carry on its authorised activities and which relate to:

(a) the construction or extension of a generating station;

(b) the operation of a generating station;

(c) in relation to, or in pursuance of, the installation, inspection, maintenance, adjustment, repair, alteration, replacement ~~and~~ or removal of:

(i) electric lines specified in paragraph 3 below;

(ii) electrical plant associated with such lines; and

(iii) any structures for housing or covering such lines or plant;

including, for the avoidance of doubt, whether these activities in sub-paragraph (c) are to be carried out by the licensee or another licence holder.

~~(b)(d)~~ in relation to the installation of electrical plant to be used in connection with a generating station or the operation thereof; and/or

~~(e)(e)~~ in relation to electric lines or electrical plant as if the references to them in Schedule 4 to the Act included pipes for conveying directly to consumers' premises heat produced in association with electricity and steam produced from air and water heated by such heat and associated works in relation to such pipes and as if "associated works" had the meaning given in section 10(3) of the Act.

3. Electric lines are specified for the purposes of sub-paragraph ~~(a)~~ (c) of paragraph 2 above and sub-paragraph (b) of paragraph 4 below:

(a) if they connect, or will connect when installed, a generating station with:

(i) the national electricity transmission system; or

(ii) any distribution system;

(b) where "electric lines" has the extended meaning given by paragraph 2 ~~(e)~~ (e) above, if they connect a generating station with any premises.

4. Paragraph 10 of Schedule 4 to the Act shall apply to the licensee if ~~(a) it wishes to~~ it obtains the consent of the Authority before exercising its rights of entry on land under that paragraph for the purpose of ~~establishing~~ ascertaining whether ~~or not~~ the land is would be suitable for:

(a) the construction or extension of a generating station; and/or

~~(b) it obtains the consent of the Authority before exercising those rights.~~ the installation, inspection, maintenance, adjustment, repair, alteration, replacement or removal of electric lines specified in paragraph 3 above, electrical plant associated with them and any structures for housing or covering such plant, including, for the

avoidance of doubt, whether these activities are carried out by the licensee or another licence holder.

5. In this condition:

“authorised activities” means the activities which the licensee is authorised by the licence to carry on, and shall include any purpose connected with the supply to any premises of heat produced in association with electricity and steam produced from air and water heated by such heat;

“generating station” has the meaning given in paragraph 3 of standard condition 14 (Compulsory Acquisition of Land etc);

“extension” in relation to a generating station, has the meaning given in paragraph 3 of standard condition 14 (Compulsory Acquisition of Land etc).
