

Modification proposal:	Green Deal Arrangements Agreement (GDAA) Change Proposal (CP) 0085 Amended Funding Provisions V2

# Background

The Secretary of State currently funds the GDAA.<sup>2</sup> The GDAA includes cost recovery provisions to provide for self-funding<sup>3</sup>, but as funding has been provided by government to date, these have not yet been used.

The Secretary of State will continue to fund the GDAA following an announcement on the financing of the Green Deal Finance Company (GDFC)<sup>4</sup> and discussions on the value of moving to self-funding (and a 'Special Purpose vehicle' model<sup>5</sup>) at this time. The GDAA needs to be changed to reflect that Secretary of State funding will continue.

# The modification proposal<sup>6</sup>

CP 0085 was raised by GDFC Assets in August 2015. It proposes a number of amendments to the GDAA provisions on the payment and recovery of costs incurred in funding the GDAA. The proposed amendments reflect that the current funding arrangements will remain in place until a time to be determined by the Secretary of State, and provide for the Secretary of State to give notice of the date for the self-funding mechanism to commence.

In accordance with paragraph 7.1.2 of the GDAA, Authority consent is required as it seeks to amend Part 2 of the GDAA.<sup>7</sup>

### **GDAA Panel recommendation**

At its meeting on 20 November 2015, the GDAA Panel agreed to approve CP 0085.

## **Our decision**

The GDAA Panel issued CP 0085 for a 20 working day Impact Assessment on 9 October 2015. 10 responses were received by the GDAA Panel, eight of which supported the proposals and two voted neutrally. We have concluded that the implementation of CP 0085 is consistent with the objective of the GDAA which is to establish an effective mechanism for:<sup>8</sup>

(a) the collection of Green Deal Charges through electricity bills by Mandatory Green Deal Suppliers and Voluntary Green Deal Suppliers; and

(b) the remittance of these payments to Green Deal Providers or their nominees, so as to enable the efficient use of energy to be promoted under the Green Deal and to do so in a way which protects the interests of consumers, promotes effective competition between electricity suppliers...and promotes the efficient use of energy.

We consider that consenting to this change is consistent with our principal objective and statutory duties.

## **Reasons for our decision**

We consider that the implementation of CP 0085 will contribute to an effective mechanism for the Green Deal by reflecting the funding arrangements that are currently in place, ie with the Secretary of State continuing to cover the costs of the GDAA. We note that the amendments allow for the self-funding provisions of GDAA to commence, should the Secretary of State determine this is appropriate.

We note that the changes to the GDAA legal drafting to give effect to CP 0085 are shown in the report against a previous version of the GDAA, which has since been changed<sup>9</sup>. The change marking in the report therefore does not show changes against the current version of the GDAA. However, we understand that CP 0085 will still be implemented correctly when these changes are reflected within the current version of the GDAA. We would expect an appropriate housekeeping modification to be progressed if this is not the case and any issues with the legal drafting come to light.

For the purposes of paragraph 7.1.2 of the GDAA, we consent to CP 0085 being made.
