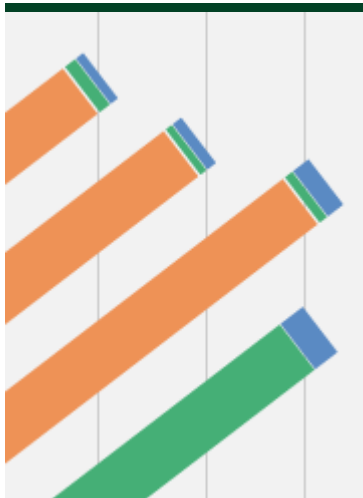

On 27 May we published a [consultation](#) on 'deemed scores'.

We expect DECC to consult soon on an extension to the current ECO scheme. We have taken the decision to consult on deemed scores now to allow us the necessary time to develop and implement them for April 2017, should they be introduced.

ECO is a government scheme to reduce carbon dioxide emissions from Britain's domestic housing and support people living in fuel poverty by funding energy efficiency improvements.

It places legal obligations on larger energy suppliers to deliver energy efficiency measures to domestic premises in Great Britain. The scheme began in 2013, and the overall obligation period for the second phase of ECO (ECO2) runs from 1 April 2015 to 31 March 2017.

Ofgem E-Serve is the administrator of ECO while DECC is responsible for the policy.
