Modification of the special conditions of the electricity distribution licence held by the above licensees

- Each of the companies to whom this Modification is addressed is the holder of an electricity distribution licence ('the licence') granted or treated as granted under section 6(1)(c) of the Electricity Act 1989 ('the Act').
- 2. Under section 11A(2) of the Act the Gas and Electricity Markets Authority ('the Authority')¹ gave notice on 20 June 2016 ('the Notice') that we proposed to modify special condition 3A the Charge Restriction Condition (Legacy price control adjustments) and the associated Part 3 of the RIIO-ED1 Price Control Financial Handbook of the licence. We stated that any representations to the modification proposal must be made on or before 18 July 2016.
- A copy of the Notice was sent to the Secretary of State in accordance with section 11A(4)(b) of the Act, and we have not received a direction that the change should not be made.
- 4. We received six non-confidential responses to the Notice, which we carefully considered. We have placed all of these responses on our website. Our response to these comments is set out in Schedule 1.
- 5. It is necessary to make a number of minor alterations to the modifications set out in the Notice. These alterations are shown in red type and underline in the attached Schedule 2. The reasons for any differences between the modifications set out in the Notice and the modifications reflected in Schedule 2 are to correct minor typographical errors and address minor issues and corrections raised in consultation responses.
- 6. For the avoidance of doubt, the alterations shown are those we have made following responses to the Notice. We are making a number of other modifications to the existing Part 3 of the RIIO-ED1 Price Control Financial Handbook which were highlighted in our Statutory Consultation².
- 7. We are making these licence changes to incorporate methodologies enabling us to close out Distribution Price Control Review 5 (DPCR5).

- 8. The effect of the modifications is to provide a process for assessing company performance under specific schemes during DPCR5(2010-2015), and where appropriate, adjusting licensees' revenues accordingly.
- 9. Where an application for permission to appeal our decision is made to the Competition and Markets Authority (CMA) under section 11C of the Act, Rule 5.7 of the CMA's Energy Licence Modification Appeals Rules³ requires that the appellant must send to any relevant licence holders who are not parties to the appeal a nonconfidential notice setting out the matters required in Rule 5.2. The attached Schedule 3 provides a list of the relevant licence holders in relation to this modification. Section 11A(10) of the Act sets out the meaning of 'relevant licence holder'.

In accordance with section 11A(1)(a) of the Act, we hereby modify the special conditions of the electricity distribution licence held by the above specified licensees in the manner specified in attached Schedule 2. This decision will take effect from 24 September 2016.

This document is notice of the reasons for the decision to modify the licence held by the above specified licensees as required by section 49A(2) of the Act.
