### Dear Stakeholder

Welcome to your latest quarterly update on the Non-Domestic Renewable Heat Incentive (RHI).

It includes an update on biogas applications, the latest tariff degressions and a first for the scheme.

### **Accreditations update**

Between July and September 2016, we accredited 669 full applications and 5 preliminary applications. Over the same period we registered 1 biomethane producer.

This brings the total to 15,509 accredited installations and 53 registered producers of biomethane in Great Britain.

# <u>Update for biogas</u> applicants

We're working to improve our process for dealing with biogas accreditations as we've recently seen an increase in the number of applications. It's currently taking about six weeks to get back to people but we're training more staff and piloting a new questionnaire for applicants which should help speed up the process.

If you're a biogas applicant then providing a timeline of commissioning dates and properly naming multiple installations on the register will help with the application process. See chapters 10 and 11 of our Guidance Volume 1 for further information about the biogas eligibility.

## A first for the RHI scheme

An innovative use of heat from sewage for a water source heat pump has recently been accredited on the Non-Domestic RHI. The system uses filtered sewage alongside naturally occurring heat to provide heating and hot water.

The system is the first of its kind in the UK and the first to be accredited on the scheme. Currently over 750 heat pumps are accredited on the RHI and we continue to see more innovative and efficient ways of utilising heat pump systems. For further information about heat pumps see our website.

### Top 5 tips from our customer service team

- 1. Know your RHI number before contacting us.
- 2. We can only discuss a case if you are registered on the account as the Authorised signatory or an additional user.
- 3. If you've responded to a reviewer's email or made changes to your application, please don't forget to resubmit it
- 4. Difficulty submitting your periodic data? See our <u>Easy</u> Guide
- 5. Once you have submitted your periodic data please allow 6 weeks for payment.

### **Degression**

From 1 October 2016, there was a 5 per cent reduction in the biomethane injection tariff and the small biomass tariff. The small, medium and large biogas tariff was reduced by 25 per cent. You can find out more about these tariff changes on our website.

## **About the Non-Domestic RHI**

The Non-Domestic Renewable Heat Incentive (RHI) is a government environmental scheme that provides financial incentives to increase the uptake of renewable heat. The scheme supports industrial, commercial, public sector, and not-for-profit organisations by making incentive payments to eligible renewable heat generators and producers of biomethane in Great Britain.

Ofgem administers the scheme on behalf of government and provides quarterly reports as part of its statutory obligations.
