Notice of statutory consultation on a proposal to modify the special conditions of the electricity distribution licences – minor corrections and typographical errors

Thank you for the opportunity to comment on the above notice, dated 9 December 2015. This response should be regarded as a consolidated response on behalf of UK Power Networks' affected distribution licence holding companies: Eastern Power Networks plc, London Power Networks plc and South Eastern Power Networks plc.

Dear Martin

We have updated the workbook as requested and checked to ensure consistency with the original Schedule D workbook.

For LPN, 19 km of 132kV gas cable removals are included in NAW7 for Eltham Sydenham cables, with

the remaining 89 asset additions in the NAW7b table. There are no HI additions for the gas cables as the replacements will be solid cables for which we do not report HIs.

For SPN all the movements are associated with the PO route and sit in NAW7. We have removed the

132kV CB in the NAW7b you provided as we believe this arose through the duplication of the tables.

For EPN the 15 132kV CBs identified in the supporting scheme paper submitted as part of the price control as being at Little Barford have been placed in NAW7 with the remaining assets as NAW7b.
