Our monthly <u>ECO2 progress</u> reports show delivery against suppliers' ECO2 targets.

The latest monthly update shows that 43,339 solid wall insulation installations have been approved under ECO2 from April 2015 to December 2016.

This updates the draft guidance issued with our part one consultation in October, and includes guidance on deemed scores. Final guidance will be published in April following our second guidance consultation.

The Department for Business, Energy and Industrial Strategy (BEIS) has published their <u>latest</u> <u>statistics.</u>

About ECO

ECO is a government scheme to reduce carbon dioxide emissions from Britain's domestic housing and support people living in fuel poverty by funding energy efficiency improvements.

It places legal obligations on larger energy suppliers to deliver energy efficiency measures to domestic premises in Great Britain. The scheme began in 2013, and the overall obligation period for the second phase of ECO (ECO2) runs from 1 April 2015 to 31 March 2017.

Ofgem E-Serve is the administrator of ECO while BEIS is responsible for the policy. You can read about Ofgem's role on the scheme on our <u>website</u>.
