1.8. Meeting Minutes

Item 1: Approval of PNSG minutes

- 1. Rob Salter-Church (Ofgem) kicked off the session by outlining the agenda and approving the meeting minutes from the previous PNSG. These can be found on the Ofgem website:

Item 3: Review of PNSG report

Review of the pack

- 3. Steve Mullins (PwC) provided an overview of the PNSG pack with highlights of where updates have subsequently been provided through the most recent PNDG report.
 - There was a question as to why the Unique Sites work was prioritised by Xoserve in place of further defect resolution. It was agreed that better communication was needed through the MTWG / PNDG / defect prioritisation calls between Xoserve and shippers on top priorities for Xoserve action.
 - The group discussed the need for a better understanding of the reasons why MT activity is slower than ideal. An investigation is underway to look into the market trials blockers to identify the causes, common themes and resolutions. In line with this, further information is now included in the PNDG pack for market trials participation with split by scenarios.
 - There is a portal submission due Friday 17th June and all are encouraged to complete this on a timely basis as this is a crucial to track progress and informs the PNDG and PNSG reports. PwC have added further qualitative questions to their portal on the challenges parties face in conducting market trials, which will be used to inform a work around removing the blockers to market trial execution and accelerating progress.
 - The Transition Progress Group (TPG) has met and developed a plan, upcoming agendas and assigned accountability for key actions.
 - A paper on GONG was issued in the 2nd June pack and will be finalised with the selection of the scenario at the end of June. Another level of detail to the GONG is required setting out how criteria will be measured. These will be developed and shared after the scenario selection, in line with the detailed planning.
- 4. A review of the risks and actions led to the following discussions:
 - Post mitigation scoring will be added to the reporting going forward.
 - Before actions are closed, the individual who raised the item will be consulted to confirm that the risk/issue has been appropriately addressed.

- 5. Rob Salter-Church thanked everyone for all of the questions and input ahead of this session.
- 6. An overview was provided of the three common topics identified through the questions by PwC.
 - The three topics are: Nexus Programme deliverability, Scenario C, Consultation process and broader impacts
- 7. Discussion around Nexus Programme deliverability included:
 - Participants reiterated that they would like to know how there will be confidence and assurance that the system will be ready in each of the scenarios. Participants also expressed that they would have found it useful to have more detail on Xoserve's views (in addition to the statement in the position paper) on the scenarios as part of the 2nd June pack. PwC and Xoserve agree in general with the risks identified in scenarios A and B, although Xoserve considers the probability of some of these risks to be lower.
 - Rob Salter-Church clarified that in submitting their Ofgem consultation responses, market participants should assume the risks / degree of confidence associated with the central system delivery is as set out in the PwC position paper.
 - PwC clarified that Xoserve had seen the scenarios shortly before they were published and had provided some views which had been taken into account in finalising the scenarios. Sandra Simpson confirmed that Xoserve is assessing the impacts of the scenarios and how they can be resourced in more detail.
 - Xoserve has stated their preferred scenario is B and that they would respond to the consultation with their formal response. Note: All non-confidential responses to the consultation will be published on the Ofgem website. Xoserve confirmed that its response would not be marked confidential.
 - Gill Williams (PwC) re-iterated the key findings from the Deep Dive as included in the Positioning Paper. The four week review, which included interviews, documentation review and reviews of source systems e.g. the defect logs, showed that the system design was considered fit for purpose. The build review showed that Xoserve is doing the right activities to prove the design and implement it, but is unlikely to be able to complete these in the current timescale and without significant risk. PwC is working with Xoserve to agree the ongoing assurance they will provide over Xoserve to avoid duplication of the work completed by Baringa.
 - Gill Williams went on to outline that PwC's preferred scenario is C as it was felt A and B were too high risk (i.e., if any one risk crystallised it would not allow for enough time to respond and resolve without impacting the go live), especially given the multiparty implementation approach. Gill Williams outlined that they recommended Scenario C on the basis of the deep dive and the planning work undertaken so far. While the final deliverability would need to be confirmed through detailed planning, they were confident that the additional time allowed in scenario C (subject to Xoserve's further considerations) would enable a much higher degree of delivery confidence.
 - Participants advised they felt they are dependent on the information provided through the 2nd June package as they do not have a clear view on all aspects of the programme.
- 8. Discussion around Scenario C included:
 - Lesley Potts (PwC) outlined the approach used to come to the four options looking at the plan from left to right and then derisking activities to allow for more time and contingency. Lesley worked closely with Colin Bezant (PwC) who conducted the deep dive to have the four scenarios address the risks found in the deep dive.
 - Gill Williams advised scenario C provides a much higher degree of confidence in date certainty than either A or B. It was felt that with scenario D there was a chance of losing momentum.
 - Participants asked Xoserve how they reconciled the PwC Deep Dive risks with their own comments at the PNSF where they stated that there were no current blockers to them achieving the 1st October go live. Sandra Simpson advised the risks identified in the deep dive were not new to Xoserve and have been reported previously to the PNSG and in Baringa documents. Xoserve acknowledge that in aggregate the risks are high but maintain that as yet none of the risks have reached a point that would absolutely prevent them meeting a 1st October go-live.
- 9. Discussion around Consultation process and broader impacts included:

- Participants requested clarification on the decision being made on 30th June. Rob Salter-Church reiterated that the aim is to make a decision on the preferred scenario at the end of June. Depending on the scenario, further planning work would follow (involving industry participants) to then set a firm implementation date. This might take 2 to 4 weeks and would depend on the scenario selected.
- The information published at the end of June will be clear on the next steps for all parties. This will include information on how the plan will be identified.
