## Notice of intention not to reject modified electricity transmission Network Output Measures (NOMs) Methodology

On 29 April 2016 we issued a direction<sup>1</sup> ("the Direction") to onshore electricity transmission licensees (National Grid Electricity Transmission plc (NGET), Scottish Hydro Electric Transmission plc (SHE-T), and SP Transmission plc (SPT) to modify their NOMs methodology.

The Direction required the licensees to submit jointly the following to the Authority for approval:

- a. A modified Common Methodology
- b. A Risk Trading Model (RTM)
- c. Calibration, Testing, and Validation Plans
- d. A report explain how a to c comply with the Direction.

On 28 April 2017, the licensees submitted the items listed above for the Authority's approval. The licensees are required to implement the proposed modifications to the NOMs Methodology unless the Authority directs<sup>2</sup> them (within 28 days of submission) not to do so.

Having reviewed the submissions, our view is that they represent a significant improvement on the previous methodology. Therefore, we are not directing the licensees not to implement the modifications. However, while we consider that licensees have used reasonable endeavours to comply with the Direction, further work will be required before the Methodology fully achieves the NOMs Objectives. We will publish the reasons for this view and requirements for futher development in the next couple of weeks.
