1.5. Meeting Minutes

Item1: Opening of PNDG meeting

- 1. Jon Dixon (Ofgem) opened the meeting by reminding participants that this PNDG report continues to be measured against the 01 Oct 16 implementation date and as such continues to reflect a red RAG status.
- 2. A broadcast of the last PNSG meeting key messages was provided by Jon Dixon. These can be found on the Ofgem website.

Item2: Approval of PNDG minutes

3. Jon Dixon (Ofgem) stated that, having not received any comment or objections to the meeting minutes from 29 Jun 16 PNDG, that these minutes will be taken as approved. These will be posted on the Ofgem website: https://www.ofgem.gov.uk/gas/retail-market/market-review-and-reform/project-nexus

Item3: Review of the Current PNDG Report

PNDG Report covering the period 24 Jun 16 - 07 Jul 16

- 3. Melisa Findlay (PwC) talked through (slide 3) outlining the upcoming PNDG, PNSG and PNSF meetings. The next working group meetings are:
 - MTWG Phone call 13 Jul 16
 - MTWG In person meeting 19 Jul 16
 - TPG Cancelled 19 Jul 16
 - TPG In person meeting 2 Aug 16
 - DMG In person and WebEx 20 Jul 16
- 4. Melisa Findlay presented the programme dashboard (slide 4) highlighting status remains the same across all pillars as seen over the last two PNDG reports.
 - A previously identified risk (Ro29) regarding the completion of Market Trials has been realised and has now escalated to an issue (Io16).

Question from PNDG Attendee:	Response:
1. In which upcoming Project Nexus governance meeting will the new go live date be specified?	The target is for the PNDG on 26 Jul 16 to discuss the new plan and the PNSG on 1 Aug 16 to approve.

- 4. Melisa Findlay provided an overview of the commentary slide (Slide 4), noting in addition to the slide content:
 - A Programme Manager's meeting is to be held 20 Jul 16 to conduct further industry planning for the new plan.
 - The file format deployment that was delayed with the P1 incidents was deployed 7 Jul 16.
 - Stress testing that was delayed due to two defects has started as of 11 Jul 16.
 - BW bulk load due 8 Jul 16 has been completed.

Question from PNDG Attendee:	Response:
2. Does the final UAT date impact anything in Market Trials?	Sandra Simpson advised Xoserve have not seen any of the conditions that would lead to these scenarios to cause an impact to Market Trials. The due date of 21 Aug 16 is in advance of the required timeframe for running the final reconciliation invoice in Market Trials.
3. Is a Market Trials Working Group (MTWG) taking place this week?	There is a Market Trials call scheduled for 13 Jul 16 at 10:00 with a follow on session on 19 Jul 16 at 10:00-15:00.

- 5. Melisa Findlay spoke about the programme plan (Slide 6) reminding participants of the requirement to complete the next portal submissions by 15 Jul 16 against meeting an end of August timeline for Market Trials. This is critical to inform the accuracy of the industry planning work going on next week.
 - Milestone D2.2 is now complete.
 - Milestone PD1.1 has been moved to 21 Aug 16. Note: subject to confirmation in detailed replan
 - Milestone PD4.2 has been moved to 15 Aug 16. Note: subject to confirmation in detailed replan
 - It was also noted that the milestones D2.3 and D3.1 are on hold until re-planning is complete.
- 6. Marian Isola (PwC) presented the Programme Risk and Issues (Slides 7 11), all updates will be applied directly to the RAID log. The following key points have been outlined below:
 - Io16 New issue raised in relation to the realisation of Ro29 which has resulted in the establishment of a Market Trials Blockers Task Force.
 - Io14 Action Ao77 amended and is being tracked through TPG in place of further PNDG monitoring.
 - Ro31 Proposed and agreed to be closed. Xoserve to refresh the links for functional readiness and open issues.
 - R045 Retained to demonstrate iDR dates, which will need to reflect re-planning once complete.
 - Ro46 Continue to monitor.
 - Ro48 This risk was proposed to be closed but through discussion it was instead decided the likelihood would be reduced from 3 to 1 and the risk would be maintained on the risk log and removed from PNDG monitoring.

4. Ro46 – What mitigation action is in place around how we are treating exceptions and how we make impact assessments?	It has been agreed that this will be addressed within the MTWG to review and refine the exit criteria and associated measures.

- 7. Sandra Simpson (Xoserve) explained the Project Delivery Progress (Slides 12 and 13) and the following was noted:
 - Where possible Xoserve will continue to drive towards the current planned dates i.e. performance testing. Other activities, particularly delta data loads in relation to iDR's, need to be looked at in re-planning.
 - Open defects in UAT, continue to make positive progress, with latest statistics showing 0 x P1, 5 x P2, 34 x P3, 1 x P4 with very few new defects being raised.
- 8. Martin Crozier (PwC) spoke through the slides on Market Trials (Slide 14 to 19) providing an update, supported by Sandra Simpson.
 - Market Trials has been impacted upon by the P1 incidents which continues to result in slow testing progression.
 - Average completion is tracking around 50% with a slow run rate.
 - Market participants are encouraged to submit portal submission by 15 Jul 16 against an end of August market trials date.
 - PNDG were introduced to the Burndown (slide 18) which has previously been presented at the PNSG. This comes from Xoserve and includes all defects (UAT and MT).
 - Sandra Simpson advised there are currently 117 defects across all 4 criticalities. Only 10 market participants joined the Friday prioritisation call. The three defects noted on slide 17 have been resolved.

Question from PNDG Attendee:	Response:
5. Based on current run-rate what is the expected completion date for Market Trials?	This information is not available and will need to be addressed after this PNDG. It should also be noted that a projection based on run-rate is a potentially flawed measure at it assumes a linear rate of completion. This may not be what was planned.
6. How was the end of August date determined for Market Trials?	This date is an indicative date based upon Scenario C planning. There will be flexibility on it, but Ofgem are keen to maintain momentum against existing timelines. Detailed planning is due to be conducted over the coming weeks and this may determine a new end date for Market Trials. Participants are asked to report to end of August for the 15 July 16 portal submission.
7. Why are Market Trial queries not reported within the PNDG report? This is Action A081.	PwC and Xoserve will consider how / where to include more detailed reporting around queries raised. This will be incorporated into the next PNDG report.

- 9. Sandra Simpson (Xoserve), supported by Lesley Potts (PwC) spoke through the slides on Data Migration (Slide 20) providing an update.
 - Post completion of the bulk load, DMCT3, and NED cycle Xoserve have paused activity to review next steps following Industry planning.
 - Xoserve confirmed the SAP BW Bulk Load had completed to plan.
 - The reconciliation of IGT data from Xoserve portfolios was not available for the DMG on 11 Jul 16 and will be picked up at the next session on 20 Jul 16. This session will also review data cleansing to provide confidence.
- 10. Philip Russ (PwC) spoke through the slides on Transition Progress (Slide 21).
 - TPG held 5 Jul 16 worked through the impact of new go-live with market participants providing further follow up close of day 12 Jul 16.
 - Market Participants have been requested if there are any additional iDR dashboard requirements, due close of day 12 Jul 16.
 - TPG scheduled for 19 Jul 16 is being cancelled. Next TPG scheduled for 02 Aug 16.

Question from PNDG Attendee:	Response:
8. The role description for the Hypercare role is doesn't reflect what was discussed in TPG, therefore are you going to look at amending the Hypercare role description?	Yes, this will be reissued with refinements. A volunteer is being requested to fulfil this role. Note: Subsequent to this PNDG meeting a volunteer has now been found.
9. Is there anything in the TPG product list that requires a clearer definition from Xoserve, so we can better understand them to aide planning?	None that have been identified.

11. Melisa Findlay spoke to the GONG (Slide 22) to state that this will be updated when a new industry plan has been agreed.

Item4: Hot Topic: Industry Planning Update, P1 Defects, MTTF, PNDG Reporting

- 12. Lesley Potts provided an update on Industry planning, next steps.
 - Invitations transmitted to all Market Participants involved in planning session to be held, Wednesday, 20 Jun 16 Wed, Holiday Inn, Solihull.
- 13. Melisa Findlay spoke about the Market Trials Task Force to explain its purpose and intent.
 - PwC led team to identify blockers to the market trials, the cause(s) (internal, Xoserve defect, partner delay), resolution plans and accountabilities in order to resolve these and accelerate market trials pace.
 - Findings and recommendations from this work will be combined with improvements noted from the defect prioritisation process, assurance site visits, MTWG and Baringa's review to lead to an overall action plan that will be tracked through PNDG.
- 14. Sandra Simpson (Xoserve) then spoke about the 3 recent P1 issues;
 - Root cause analysis to be provided to Project Nexus stakeholders on 22 Jul 16 for the first and third P1 and on 29 Jul 16 for the second P1.
- 15. Melisa Findlay (PwC) highlighted that the PNDG reporting is to be reviewed in line with the industry planning and market participants were invited to volunteer to be involved with developing the PNDG report.

Question from PNDG Attendee:	Response:
10. Is it worth having a contingency session identified in case follow on is required from the industry planning session booked for 20 Jul 16?	There is a PNDG meeting for the following week 26 Jul 16, there may be an option to extend PNDG if required as an overrun. PwC will review availability and options to plan any contingency meeting.
11. Who is involved with the Market Trials Task Force and what is its construct?	It is made up of PwC resources and structured according to capability.
12. Is there going to be a lessons learnt session centred on the P1 incidents?	There is an internal Xoserve lesson learnt which is held after the RCA's are fully completed and approved. Once the external RCA's are issued, as with the other P1's, Market Participants will be invited to give their feedback.

- 16. Mike Fensome (Npower) raised a new topic to discuss; User pay committee is not included in the Nexus related items in the data portfolio report.
 - User Pays Committee have approved changes to the Registered User Portfolio report which does not include Nexus related data items (Fixed AQ, Fixed SOQ and class) which were previously agreed in the report design.
 - Voting required 4 people to reject Xoserve's proposal equating to 20% of the voting rights. Voting achieved 4 people rejecting, equating to 19%. Anybody not voting was assumed to support Xoserve's position of not including these data items.
 - Npower have built to the original specification that was agreed in May 2015.
 - Highlighted to raise awareness at PNDG as npower are concerned at the lack of engagement at User Pays Committee and that the information may not have been shared within Market Participants Nexus delivery programmes.
 - Participants wishing to raise concerns on not having these data items in the Registered User Portfolio report can do so to Mike.Fensome@npower.com so he can provide a consolidated view of impacted parties.
