

### Cutover – High Level PoaP (as of 25/05/17 08:00)







#### Industry Progress Summary as at 12pm on 25/05

- PwC/Ofgem are formally contacting the 2 Market Participants (I&C8 and GT2) that are late in reporting their cutover update.
- 1 Market Participant (I&C7) missed their initial Go Live decision, but believes this can be rectified prior to 28 May. They are currently tracked as amber and are being monitored closely.
- All iGTs have confirmed the successful completion of file processing prior to entering the NED period.
- Communications have been received from Shippers that files in the Nexus format are being produced, ready for release on 01 June.
- A daily Industry Monitoring Dashboard is available on the Xoserve TPG Website. This is updated every working day at approximately 2pm.
