Modification of Special Conditions 1A and 11C of National Grid Gas plc's gas transporter licence

We¹ are making changes to National Grid Gas plc's (NGG's) gas transporter licence (the "Licence") to make sure it reflects arrangements to release incremental capacity at Interconnector Points (IPs).

We published a statutory consultation and covering letter about our proposed changes on 1 August 2017.² These documents explained our reasons for proposing changes to NGG's licence and sought views from stakeholders. The deadline for representations on the proposed modifications was 29 August 2017.

A summary of the responses we received to our consultation is included below. We also explain our decision to make these changes to the Licence.

Summary of statutory responses and our views

We received one response, from NGG, to the statutory consultation. This response was non-confidential and has been published on the Ofgem website.³

NGG agreed with the changes to Special Condition 1A. They noted the amended definitions for 'PARCA'⁴ and 'PARCA Applicant' will give certainty to the regulatory framework for the release of incremental capacity at IPs on the National Transmission System.

They also agreed with the amendments to Special Condition 11C noting that they will make sure design fees related to IP PARCAs are treated in the same manner as the existing PARCA process. We agree with both these comments.

NGG noted that they wish to continue discussions with us about situations where an economic test to release incremental IP capacity is passed and the design fee is returned to the PARCA applicant. In this situation, NGG would like to recover the design fee through the Price Control Financial Model. We are content to take part in these discussions.
