Q1.

Do you agree with our proposal to opt for *SCR Option 3: Ofgem leads an end-to-end SCR process, as outlined on pages 5-6 of the Launch Statement?*

We agree that option 3 will provide Ofgem with the best framework to lead and direct the SCR and the consequential code changes.
We fully support the exclusion from the TOM of the question on centralisation of Supplier agents' functions.
Having been provided with the list of opportunities for consultation and engagement in Appendix 1B, we are reassured that the Industry will be able to fully voice its views and provide supporting evidence. We are particularly pleased by the assurance that a formal consultation on the question of a possible centralisation of Supplier Agents functions is planned. We agree that this question should not be part of the TOM.
We also noted the willingness to get inputs from Suppliers and Supplier agents on that question before the consultation is issued via an RFI.
We have previously voiced our views on the matter and are happy to participate in workgroups or provide information via the RFI process or other methods.

Do you agree with our proposed governance model for the Target Operating Model, outlined on pages 6-8 of the Launch Statement and detailed in Appendix 2A? This includes the Terms of Reference for the DWG and DAB in Appendices 2C and 2D.

We support the proposed governance model for the TOM.

The Terms of Reference for the DWG and DAB are very clear. We support Elexon's role as the DWG chair and Ofgem as the DAB's chair.

We support the requirements to have people from different areas of the industry represented in the DWG to avoid a consensus from the beginning as the different views and expertise need to be explored to define the most appropriate TOM options and Recommendations.

We welcome the additional layer of expertise and review provided by the DAB and TOM Board before the TOM Designs and recommendations are passed to the Ofgem Senior Responsible Owner for decision.

We would like to get clarification on how much of the industry's input /feedback will be taken into consideration by the DWG for the establishment of the TOM and the final decision by the Ofgem Responsible Owner.

Do you agree with the Target Operating Model Design Principles, set out in Appendix 2B?

The Design principles listed in appendix 2b, relating to the Settlement Timetable, Data retrieval and processing, Data estimation, treatment of non-half-hourly settled customers, COMC process for the mass migration to HHS, settlement of export, Network charging and Transition do cover the expected areas of the HHS TOM. We would like Data validation to be clearly listed in the Data Retrieval and Processing area. .
