**Smart Meter Communication Licence<sup>1</sup> (“the Licence”)  
Consent to reduce the notice period for proposing an amendment to the Service  
Charges in respect to price control determinations for Regulatory Year  
2016/17.<sup>2</sup>**

Conditions 19.9 and 19.10 of the Licence prohibits Smart DCC Ltd (“the Licensee”) from amending its Service Charges unless it has given Notice in the specified manner to the Gas and Electricity Markets Authority (“the Authority”). That Notice must be given not less than three months before the date when the Licensee proposes to amend its Service Charges<sup>3</sup>, except where the Authority otherwise consents.<sup>4</sup>

On 22 December 2017, the Licensee submitted Notice to the Authority of DCC’s Service Charges for the Regulatory Year ending 31 March 2019.

Under Licence Condition 36.4 the Licensee, in setting Service Charges for its Mandatory Business Services, must take all reasonable steps to secure that, in Regulatory Year t, its Regulated Revenue does not exceed a prudent estimate of its Allowed Revenue for that Regulatory Year. Under part G of licence condition 36, DCC is subject to a ‘Report and Direct’ penalty interest rate regime for any over-recovery from users beyond 110% of Allowed Revenue.<sup>5</sup>

On 21 February 2018 the Authority made a decision under Part B of Licence Condition 37 to exclude certain costs from any future calculations of the Licensee’s Allowed Revenue. The Authority determined an adjustment to the Baseline Margin Values specified in



Licence Condition 36 Appendix 1, which has the effect of increasing the total sum by £6.769 million for RY18/19. The Authority also determined an adjustment to the External Contract Gain Share term in accordance with Licence Condition 39, which has the effect of increasing Allowed Revenue by total of £3.261 million over RY18/19-20/21.

In accordance with Licence Condition 19.10 the Authority hereby consents to the Licensee giving less than three months' notice in respect of proposing an amendment to Service Charges for the Regulatory Year ending 31 March 2019 to reflect our determinations under the price control for Regulatory Year 2016/17.

**Consent given by the Gas and Electricity Markets Authority ( the "Authority") pursuant to Licence Condition 19 (Charging Statement for Service Charges) of the Smart Meter Communication Licences granted pursuant to Sections 7AB(2) and (4) of the Gas Act 1986 and Sections 6(1A) and (1C) of the Electricity Act 1989 to Smart DCC Ltd ("the Licence").**

Whereas:

1. Smart DCC Ltd<sup>6</sup> (the "Licensee") is the holder of the Licence.
2. Under Condition 19.10 of the Licence, the Licensee may only amend its Service Charges in respect of any Agreement for Services if it does so in accordance with condition 19.9, except if the Authority otherwise consents.
3. Under Condition 19.9 of the Licence, the Licensee must give the Authority a Notice of its proposals to amend its Service Charges in respect of any Agreement for Services not less than three months before the date on which the Licensee proposes to make the amendments.
4. On 22 December 2017 the Licensee published its Services Charges for Regulatory Year 2018/19. These will be in effect between April 2018 and March 2019.
5. On 21 February 2018 the Authority gave its price control decision in relation to Regulatory Year 2016/17 (the "2016/17 price control"). This found that:
  - £0.923 million of internal costs were not economically and efficiently incurred (the "Unacceptable Costs"); and
  - the proposed Relevant Adjustment to the Baseline Margin Values specified in Licence Condition 36 Appendix 1 shall be amended such that those Values are adjusted by increasing the total sum of £6.769 million for RY 2018/19 (the "Baseline Margin Adjustment")
  - The proposed Relevant adjustment to the External Contract Gain Share term in accordance with Licence Condition 39, which has the effect of increasing Allowed Revenue by total of £3.261m over RY2018/19-2020/21
6. As a consequence of the 21 February 2018 price control decision the Authority directed the Licensee to:
  - exclude the Unacceptable Costs from the calculation of its Allowed Revenue under Licence Condition 36. This affects the value of the Allowed Revenue for Regulatory Year 2016/17, which in turn affects the calculation of Allowed Revenue for subsequent Regulatory Years; and
  - reflect the Baseline Margin Adjustment in the calculation of Allowed Revenue in Regulatory Year 2018/19.
  - reflect the proportion of the External Contract Gain Share adjustment in the calculation of Allowed Revenue in Regulatory Year 2018/19 amounting to £1.630m.



7. The Authority notes that the Licensee has not been able to adjust its Services Charges for Regulatory Year 2017/18 to reflect these price control decisions of the Authority. The Authority therefore considers that consent should be given to the Licensee to amend the Services Charges in Regulatory Year 2018/19 to reflect these decisions.

**Now** the Authority consents as follows:

8. Pursuant to Licence Condition 19.10 of the Licence, the Licensee may give less than three months' Notice of proposed amendments to the Service Charges to reflect the outcome of the Authority's decisions in respect of the 2018/19 price control.
9. This document also constitutes a notice under section 38A of the Gas Act 1986 and section 49A Electricity Act 1989 of the reasons for the decision of the Authority to give this consent pursuant to the Condition.
