Erratum to the Direction to make modifications to the Regulatory Instructions and Guidance (RIGs) for RIIO-ED1 (version 4.0)

On 16 April 2018, we published a direction¹ which issued modifications to the RIGs. The modifications took effect on and from 1 April 2018.

Following the publication of this direction, it was highlighted to us that there were formulae errors within the Connections Reporting pack. Additionally, in our response² we stated that changes were made to the Connections Reporting pack, the SLC12 15 and 15a Reporting pack and Annex G Connections guidance, however, these changes were not included as expected. Therefore, we have reissued these Reporting packs and the Annex G Connections guidance as version 4.1, which have been updated to reflect these changes. We have also published an updated response log – comments following the publication of the direction are highlighted blue. Please note that these changes take effect from the 1 April 2018 also.

Please also note the addition of a comment in line 68 of Annex B of the log regarding the Strategic Performance Overview also highlighted blue. WPD's response to the consultation was not included in the direction. This has now been included and a response provided. There is no change to the related commentary.
