Proposal to make modifications to the Regulatory Instructions and Guidance

Thank you for the opportunity to provide comments on the proposed modifications to the Regulatory Instructions and Guidance (RIGs) and Electricity Distribution Reporting Packs.

SSEN has been working with Ofgem and the other DNOs to ensure that the proposed modifications to the RIGs and Reporting Packs provide a comprehensive overview of DNO performance, to the level of granularity required, while reducing unnecessary reporting in certain reporting packs.

Overall, SSEN is supportive of Ofgem's proposed modifications to the RIIO-ED1 Regulatory Instruction Guidance and Reporting Packs in this consultation. We have reviewed the RIGs Annexes, Reporting Packs and Commentary documents, and SSEN's detailed comments are provided in Appendix 1.

SSEN have recently been granted permission by Ofgem to conduct a 3-year trial to offer Part Funded Reinforcement (PFR) which we had originally intended to report in the CR10 – ICP PFC tab in the Connection Reporting Pack. However, we fully agree with the objectives of the new proposed reporting format, to create a more streamlined pack with more concise information, meeting Ofgem requirements. We believe that reporting table CC4 –Completed Summary is a more appropriate alternative and propose to report the PFR connection jobs within this. This will allow us to capture costs as in any other connection job and report the detailed breakdown of the PFR connection jobs separately to Ofgem in a focused and succinct format to that of CR10. This will capture the relevant costs, and may develop through learning and Ofgem engagement as the trial progresses. We will continue to feed this learning into future developing of the Connections Reporting Pack.
