Commission priorities – informal Member State meeting June 2018

Three priority areas:

- Mirroring exercise with the Clean Energy Package (CEP)
- Improving the market
- Sector coupling and decarbonisation (study launching in September)

Ongoing amendments to the scope of the Gas Directive.

Recent work on amendments to the Network Codes has been dropped.



EU storage studies

6 July, FSR - GIE Policy workshop "The Value of Energy Storage in supporting EU's Security of Supply and Decarbonisation Goals"

Conclusions: "positioning the storage business with respect to climate change, we can see that positive externalities generated by SSOs need to be assessed and internalised within the new regulatory framework to ensure SSOs continue delivering these services in the future."

GIE and FTI launched a study to look at ways to internalise the value of storage.

CEER not intending to launch new work in this area.



CEER regulatory gas strategy work

To support the Commission's work on sector coupling, CEER is undertaking a Regulatory Gas Strategy work stream.

Builds on Future Role of Gas (FROG) study.

Consultation document expected Q4 2018.

Aims to identify what energy regulation can do in order to foster the development of a sustainable gas sector.

The goals are:

- (1) to identify the regulatory challenges for an efficient transition of the gas sector towards a low-carbon energy demand scenario; and
- (2) to identify possible enabling factors that the NRAs could apply to make this transition possible and smooth.
