Gas Act 1986 Section 23(1)(b)

Modification of the standard conditions of all gas shippers' licences

- 1. Each of the licensees to whom this document is addressed has a gas shippers licence which has been granted or treated as granted under 7A(2) of the Gas Act 1986 ('the Act').
- Under section 23(2) of the Act the Gas and Electricity Markets Authority ('the Authority')¹ gave Notice on 16 October 2018 ('the Notice') that we propose to modify standard condition 18. We stated that any representations to the modification proposal must be made on or before 16 November 2018.
- 3. A copy of the Notice was sent to the Secretary of State in accordance with section 23(4)(b) of the Act, and we have not received a direction that the change should not be made.
- 4. We received 39 responses to the Notice, which we carefully considered. We have placed all non-confidential responses on our website. Our response to these comments is set out in the accompanying letter.
- 5. We are making these/this licence change(s) and placing a duty on gas shippers licencees to cooperate with the Authority or any person(s) appointed by the Authority, as may be required to give full effect to the conclusions of a Significant Code Review. This is to ensure a continuity of effective programme governance beyond the point at which the Authority may direct modifications to relevant licences and/or industry codes, through the design, build and test phase to the subsequent implementation of associated IT systems.
- 6. The effect of the modification(s) will be to:
 - a) delete the defunct requirements within standard condition 18 and replace them with a duty to cooperate with the Authority in delivery of a Significant Code Review; and
 - b) include definitions of new terms where appropriate.
- 7. Where an application for permission to appeal our decision is made to the Competition and Markets Authority (CMA) under section 23B of the Act, Rule 5.7 of the Energy Licence Modification Appeals: Competition and Markets Authority Rules² requires that the appellant must send to any relevant licence holders who are not parties to the appeal a non-sensitive Notice setting out the matters required in Rule 5.2. The attached Schedule 2 provides a list of the relevant licence holders in relation to this modification. Section 23(10) of the Act sets out the meaning of 'relevant licence holder'.

- 9. This document is Notice of the reasons for the decision to modify the gas shippers licences as required by section 38A of the Act.

Schedule 1 - Modification of Standard Condition 18 of the gas shippers licence

Deletions are shown in strike through and new text is double underlined.

Delete:

Condition 18. Change Co ordination for the Utilities Act 2000

- The licensee shall take all reasonable measures to secure and implement, and shall not take
 any steps to prevent or unduly delay, such changes to the industry framework documents as
 are necessary or expedient to give full and timely effect to the provisions of the Utilities Act
 2000.
- 2. In complying with paragraph 1, the licensee shall act in the case of each industry framework document consistently with the change procedures currently applicable to that document, except where to do so would be inconsistent with any provision of the Utilities Act 2000, in which event that provision shall take precedence.
- 3. For the purposes of this condition, "industry framework document" means, subject to paragraph 4, any of the following documents to which the licensee is a party, or in relation to which it holds rights in respect of amendment or termination, together with any documents which are supplemental or ancillary thereto
 - (a) Network Code(s), and ancillary documents of that code, including
 - The Operational Guidelines
 - Energy Balancing Credit Rules
 - Code Credit Rules
 - Invoice Query Estimation Methodology
 - Transco's Maintenance Programme
 - National Gas Supply Emergency Procedures
 - Operations Reporting Manual
 - Validation Rules
 - UK Link Manual
 - LDZ Shrinkage Adjustments Methodology
 - (b) Agreements relating to Quantum Office
 - (c) Advanced Reservation Capacity Agreements
 - (d) Network Exit Agreements
 - (e)-Network-Entry Agreements
- 4. Where the Authority considers that the list of industry framework documents set out in paragraph 3 should be modified for the purposes of this condition generally, the licensee shall discuss any proposed modification (including addition) to the list in good faith and use all reasonable endeavours to agree such modification with the Authority.



5. This condition will cease to have effect on 30 June 2002 or such earlier date as the Authority may specify in a direction given for the purposes of this condition generally.

Insert:

Condition 18: Duty to cooperate

- This condition shall apply where the licensee has entered into a framework agreement or otherwise acceded to a Network Code of a relevant transporter.
- The licensee will cooperate with the Authority and/or any person(s) appointed by the Authority or appointed pursuant to a direction of the Authority, to undertake any reasonable requests in relation to planning, project assurance and/or coordination/systems integration in order to give full effect to the conclusions of a Significant Code Review.
- Cooperation for the purposes of condition 18(2) may include but not be limited to:
 - a) the sharing of such information as reasonable, and constructive participation in industry engagement in order to undertake appropriate planning of changes to IT systems or industry standard operational processes system changes pursuant to the conclusions of a Significant Code Review;
 - b) the provision of such data as may be identified and reasonably requested in order to undertake testing and/or the population of any new central systems;
 - c) the preparation and cleansing of such data as may reasonably be requested in order to facilitate live operation of the new central system;
 - d) the provision of test scripts and results of any testing as may be requested by any person appointed to assure the success of any testing;
 - e) all reasonable steps to:
 - meet key programme milestones for the completion of any action(s) assigned to the licensee;
 - ii) adhere to any remedial plan put in place to address any issues, delays or slippage that may impact the licensees ability to meet programme milestones, to the extent that failure to do so may jeopardise the successful and timely implementation of the programme;
 - iii) identify any dependencies that the licensee may have upon agents or other third-parties and secure the necessary support from such parties; and,
 - iv) promptly escalate and/or resolve any disputes that if unresolved may jeopardise the fulfilment of these obligations.

Interpretation

4. In this condition:

Significant Code Review means a review of matters in relation to its principal objective and/or general duties (under section 3A of the Electricity Act or section 4AA of the Gas Act), statutory functions and/or relevant obligations arising under EU law, which the Authority considers are likely to relate to one or more of the documents referred to in this condition, or to which the licensee is required under this licence to be a party, and concerning which the Authority has consulted upon



and issued a Notice to the parties stating that the review will constitute a Significant Code Review.
