Gas Act 1986 Section 23(1)(a)

Modification of Special Condition 1A of the gas transporter licences held by the licensees listed above

- 1. The licensees listed above are each the holder of a gas transporter licence ('the Licence') granted or treated as granted under section 7 of the Gas Act 1986 ('the Act').
- 2. Under section 23(2) of the Act, the Gas and Electricity Markets Authority ('the Authority')¹ gave notice on 20 December 2018 ('the Notice') that we propose to modify Special Condition 1A of the Licence.² We stated that any representations to the modification proposal must be made on or before 22 January 2019.
- 3. A copy of the Notice was sent to the Secretary of State in accordance with section 23(4)(b) of the Act, and we have not received a direction that the change should not be made.
- 4. We received two responses to the Notice, which we carefully considered. We have placed these responses on our website. Our response to the comments received is set out in the letter accompanying this notice.
- 5. It is necessary to make a minor alteration to the modifications set out in the Notice in order to correct a typographical error in the publication date of the Workbooks. This alteration is shown in yellow highlight in the attached Schedule 1.
- 6. We are making these licence modifications in order to change the definition of 'Workbook' in SpC 1A.4 to refer to Workbooks which better align with our RIIO-GD1 Final Proposals, as published by the Authority on 19 December 2018.³
- 7. The effect of the modifications will be that:
 - the definition of 'Workbook' will refer to those "as published by the Authority on 19 December 2018", and
 - the text in the 'Workbook title' column of the table will be:

"Schedule 2: Appendix to Special Condition 4H Specification of Network Outputs – Cadent EOE – Final"

- 8. Where an application for permission to appeal our decision is made to the Competition and Markets Authority (CMA) under section 23B of the Act, Rule 5.7 of the Energy Licence Modification Appeals: Competition and Markets Authority Rules⁴ requires that the appellant must send to any relevant licence holders who are not parties to the appeal a non-sensitive notice setting out the matters required in Rule 5.2. The attached Schedule 2 provides a list of the relevant licence holders in relation to this modification. Section 23(10) of the Act sets out the meaning of 'relevant licence holder'.

Pursuant to section 23(1)(a) of the Act, we hereby modify Special Condition 1A of the Licence of the licensees listed above in the manner specified in attached Schedule 1. This decision will take effect from 28 March 2019.

This document is notice of the reasons for the decision to modify the Licence held by the licensees listed above as required by section 38A of the Act.
