Chart 1: Deployment caps utilisation (by technology type)

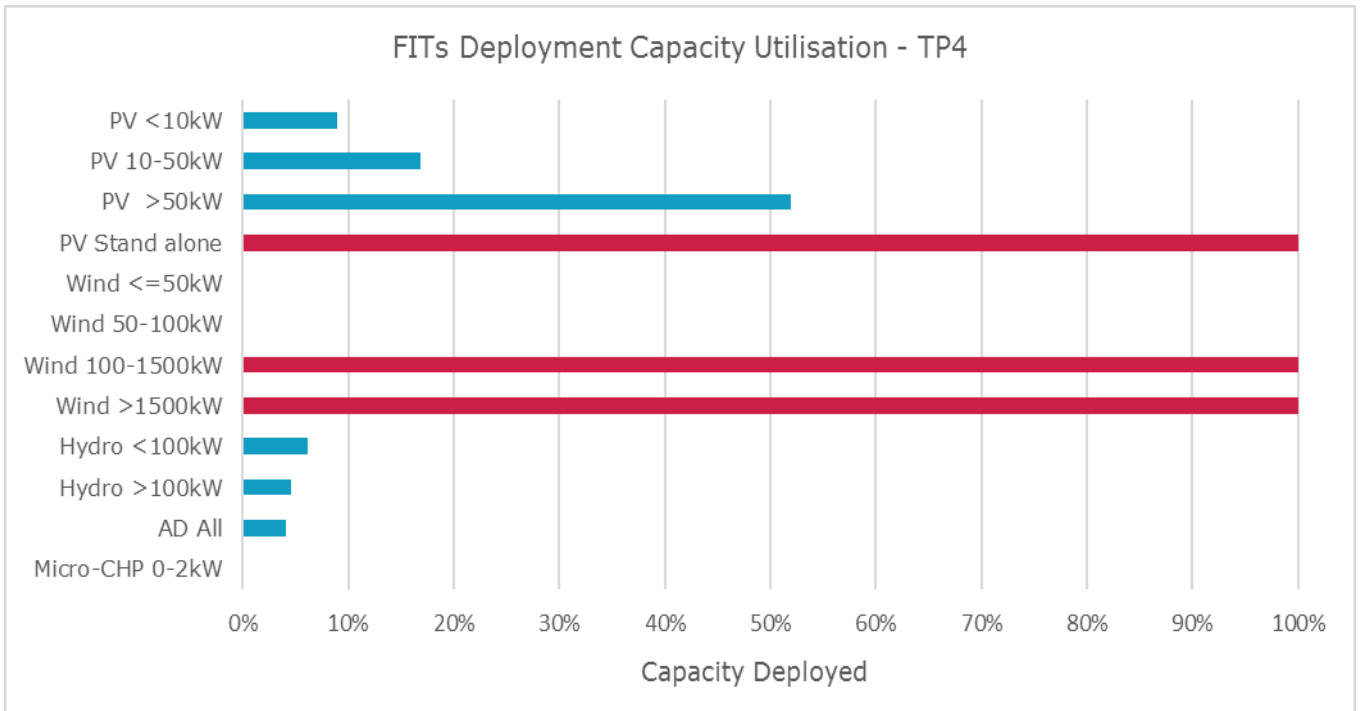
