WWU Response to Ofgem's Statutory consultation on Gas Distribution Network Output Measures Rebasing – 20th March through to 15th May 2019

WWU welcome the opportunity to comment on Ofgem's consultation on their intention to approve the Rebased Network Outputs for Gas Distribution Network operators under Part E of Special Condition 4H of the Gas Transporter Licence.

We supported the modifications proposed in phases 1 & 2 of the Ofgem NOM's rebasing consultation

- 1. Updated health and Risk targets
- 2. Modification of the definition of 'Workbook' in SpC 1A.4

Please find below, our response to the three questions published by Ofgem in phase 3

Question 1: Do you agree with our rebasing assessment methodology? Where you disagree, please clearly set out your reasoning and specify other considerations/factors we should take into account.

In our opinion, the tests laid out in the assessment methodology are thorough and challenging. They robustly challenge all aspects of a GDNs intervention plan's impact on asset health and risk in the two methodologies, HI/RI and Monetised Risk

Question 2: Do you agree with our view that the Rebased Targets satisfy the licence requirements? Where you disagree, please clearly set out your reasoning.

Significant volumes of data and analysis has been exchanged between the GDNs and Ofgem to validate that the GD1 Monetised Risk targets are as equally challenging as the original GD1 HI & RI targets
