Derogation from the Prohibition of Dead Tariff rules to exit the supply of SVTs

This letter sets out the decision of the Gas and Electricity Markets Authority¹ (the "**Authority**") to grant British Gas Trading Limited (Company number 03078711; the "**Licensee**"), a temporary and limited derogation from certain elements of standard licence condition ("**SLC**") 22D of its gas and electricity supply licences.

The directions are attached to this letter and will be published on our website. They are effective from 1 July 2019 until 31 October 2020, unless revoked earlier or varied in writing by the Authority. Any change in circumstances relevant to the directions must be reported to the Authority without delay.

This letter constitutes the notice, under section 49A of the Electricity Act 1989 and section 38A of the Gas Act 1986, of the reasons for the Authority's decision to issue the attached directions. Capitalised terms used in this letter, which are not defined herein, have the meaning given to them in the standard licence conditions of gas and electricity supply licences.

Background to the direction request

The Authority received a written application from the Licensee on 12 April 2019 for a derogation from paragraph 1 of SLC 22D of its gas and electricity supply licences. The Licensee has previously been granted a related derogation on 29 March 2018 from certain elements of SLC 22D by the Authority, which is due to expire on 30 June 2019.² The Licensee's application amounts to a request to extend the existing temporary and limited derogation.

The Licensee has stated that the objective of its approach is to maximise customer engagement by encouraging its customers to sign up to Fixed Term Contracts ("**FTCs**"). The Licensee had previously published its views on why it wanted to shift the focus of its business model from Standard Variable Tariffs ("**SVTs**") towards FTCs on its website.³

The Authority's Decision

Based on the information provided by the Licensee, and having regard to our principal objective and statutory duties, the Authority has decided to issue the requested derogation. However, it is a condition of this derogation that the Licensee provides the Authority with further evidence by 31 October 2019, to demonstrate the extent to which the derogation has achieved its stated objective of a positive impact on consumer engagement, for those customers on the Licensee's Dead Tariff named "Temporary Tariff". This is to provide assurance that the derogation has delivered benefits to affected consumers.

The Authority has decided to issue the requested derogation for the following reasons:

- We do not consider that the proposal by the Licensee goes against the objectives of our retail market policies, which are focused on protecting customers' interests and stimulating competition;
- We have committed to encouraging and providing suppliers with flexibility to deliver better outcomes for customers, which includes supporting initiatives that may increase consumer engagement; and
- Since the existing derogation was granted, the Authority has implemented the default tariff price cap.⁴ The Licensee's customers are also protected by the default tariff price cap when moving onto the Licensee's Dead Tariff.

Under these directions, the Licensee must inform the Authority without delay of any changes in circumstances that are relevant to the decision to grant this derogation.
