Latest news

L1-05 milestone decision

On 31st May the Delivery Group held a checkpoint meeting to discuss the progress towards the near term Level 1 milestone L1-05 (Baseline external physical interface design). While acknowledging that a lot of positive work had been undertaken to date, the Delivery Group decided to accept the DCC proposal to bring the draft external physical interfaces to consult with industry on 28th June.

Ofgem, DCC, the System Integrator and the Programme Coordinator will undertake a replan of the industry consultation phase to ensure that there is sufficient time to consult with licensed parties in the lead up to the L1-05 milestone. This draft plan will be bought back to the Delivery Group at the scheduled meeting on 18th June.

For L1-05 and L1-06 (Programme Parties Mobilised) participants can expect an approximately 3-4 week delay. Further detail on the exact timeframe will be provided at the next Delivery Group meeting.

CSS contract award

DBT entry

The contract award to Landmark enabled the Switching Programme Delivery Group to take a decision on 14th May for the Programme to enter the Design, Build, Test (DBT) phase.

This is a significant milestone for the Programme and allows us to now undertake a replanning exercise for the DBT phase, collaboratively with all our providers now on board. We have now published our <u>Full Business Case</u>, where we provide an update on all key developments since the publication of the Outline Business Case in February 2018.

Procurement wrap up

With the above news, we thought it timely to provide a summarised view at the various procurements that have now been concluded:

- <u>Programme Coordinator</u>: PwC were awarded this contract following the Ofgem-led procurement and on boarded to the Programme in January. They're now leading on industry coordination and E2E programme assurance,-providing our PMO function as well as providing advisory services to the SRO and Programme Director.
- <u>Core Systems Assurance and Licensed Party Assurance</u>: Expleo have been appointed as the Core Systems Assurance provider and began embedding in to the Programme during April. They will be providing assurance to Ofgem over the existing systems providers, Landmark, Netcompany, and DCC. Moorhouse, part of the Expleo Group of companies, have been awarded the Licensed Party Assurance contract, and will be conducting assurance over licensed parties progress and readiness at key milestones in the Programme.
- <u>Central Switching Service</u>: Landmark Information Group Ltd, as detailed earlier in this newsletter.
- <u>Systems Integrator</u>: Netcompany, who began on boarding to the Programme in February. They will be responsible for coordinating the DBT phase activity between new and existing system providers.



DCC have just one more procurement ongoing:

• <u>Service Management Tool</u>: Contract negotiations are ongoing and we expect DCC to announce the winning bidder in June.

REC accession & RECCo invoices

We have been reaching out to organisations that have so far not been engaging with the Switching Programme requests to participate in mobilisation or DBT readiness surveys, to remind parties of their obligations under their licenses: to accede to and comply with the REC, and their duty to cooperate with giving effect to a Significant Code Review (SCR).

RECCo is in the process of issuing the initial invoices to the nominated REC contract managers and/or finance teams of Gas and Electricity suppliers, in accordance with the REC. For the avoidance of doubt, this will include any suppliers who have not yet acceded and provided relevant contact details, but should have. The RECCo website will shortly go live, along with a mailbox where such queries may in future be directed. Data updates

Electricity Stage 0 Update

As you will be aware on 27th June a major release to MPAS will take place to deliver a range of changes to support Transition Stage 0 activity for the Programme. This will see a new Related MPAN indicator included in MPAS, the re-direction of existing data flows from metering agents and the migration of data from ECOES, all in preparation for data migration to the CSS later in DBT.

The changes are being coordinated by Gemserv on behalf of the MRA's Faster Switching Expert Group (FSEG). Testing of the changes is well underway and a dress rehearsal is scheduled for the weekend of 15th June. Plans have been shared with impacted parties. Data cleansing activity to support the Stage 0 work as well to improve switching reliability remains ongoing with cleansing reports available for suppliers and (i)DNOs. For more information on cleansing or to access your report please contact <u>FSEG</u>.

Data Management Principles

The Design Authority have now approved the Switching Programme's first set of Data Management Principles. These are available on the website <u>here</u>.

These have been developed to provide industry with clarity on our End to End approach to data and will be applied to the definition of new switching messages and associated formats



and structures. It is anticipated that these will be further amended ahead of go-live for enduring operations and included within the REC Technical Specification (Data Specification).

What's coming up

Readiness assessment

The next programme readiness assessment will be for the Programme Parties Mobilised Milestone currently due for 1st August 2019, but now expected to be mid-late August when the near-term milestone plan is baselined at the Delivery Group on 18th June. We will be adopting a similar approach to the Design, Build and Test (DBT) entry milestone and we will request self-assessment against a set of agreed criteria. The criteria are including the Programme Parties Mobilised Readiness Assessment Framework, which was issued as part of the supporting information for the Switching Programme Implementation group.

We will look to run 2 self-assessments ahead of the final decision, which will be taken by the Switching Programme Delivery Group. This will give us early visibility of issues and allow us to take mitigation actions where required. The self-assessment was expected to be launched on the 13th June with submissions deadlines of 28th June and 19th July 2019 however, these dates will now change based on the near term plan checkpoint on 31st May 2019 and are likely to be July and August.

We will schedule in briefing WebEx sessions in June to talk industry through the readiness assessment process; however, ahead of these if you have any questions on the framework please contact <u>SwitchingPMO@ofgem.gov.uk</u>.
