Switching Compensation

The first tranche of our new Guaranteed Standards for Switching became effective on 1st May. Guaranteed Standards are minimum service levels which all suppliers must adhere to. If the supplier breaches the Guaranteed Standard in a switch, they will be required to make an automatic compensation payment to the affected customer. They are intended to sit alongside (rather than supersede) the work of the Switching Programme.

This first tranche focused on resolution of (rather than cause of) erroneous switches, and refunding credit balances. All suppliers are now required to compensate domestic customers if they fail to resolve erroneous switches or refund credit balances within a set time period. In July we made a Request for Information (RfI) to collect data on how many compensation payments had been made against these new Guaranteed Standards. This RfI is mandatory for all suppliers who supply domestic customers. Suppliers should have received an email and hard copy letter outlining the details of the RfI, and these details can be found here.

We are currently working on a consultation and Statutory Instrument to introduce the second tranche of Guaranteed Standards. The second tranche will cover delayed switches, causes of (rather than the resolution of) erroneous transfers, and delays to the issue of final bills. We expect to publish this in late summer or early Autumn, and all participants in the Switching Programme will have the opportunity to respond to the consultation and Statutory Instrument.

Programme plan re-baseline

Now that the Programme has all DCC service providers on boarded, we've been busy revising the Programme Plan and expect to take this to the Delivery Group for re-baselining in August.

Regulatory Group

Our latest <u>Retail Energy Code consultation</u> will close on 9th September. In advance of its closure we are planning towards the activity and decisions that will need to be taken through Switching Programme governance to enable the implementation of REC v2.

We published in our Full Business Case earlier this year the complete Switching Programme governance structure for the DBT phase, which included a new Regulatory Group to take decisions. We are now looking to set this group up to be ready for the first regulatory decisions required following our consultation.

As set out in the Full Business Case, the Regulatory Group will be based on a representative model including the following groups:
