Data request for REL creation

All DNOs, energy suppliers, and Gas Transporters (as parties to the Retail Energy Code) will have recently received a letter from DCC formally requesting data items in order to progress the creation of the Retail Energy Location (REL).

This is a reminder to those parties to please send through your questions or concerns with complying with this request as soon as possible to DCC at contact.switching@smartdcc.co.uk, and no later than 16th September. The deadline for the submission of the data items is Friday 18th October.

Switching Programme SRO

You may have heard the recent news about our Programme's Senior Responsible Officer (SRO) announcing his upcoming departure from Ofgem. Rob will be finishing up with Ofgem at the end of September.

Rachel Clark has been appointed as the temporary SRO for the Switching, Smart and Half-Hourly Settlement Programmes.

This minimises any risk of a new SRO looking to change the direction of the Programme.

DCC stakeholder survey results

Wave 3 of the DCC stakeholder engagement survey was completed in July. The results of the survey and DCC's response have been published <u>here</u>.



Near Term Milestone Plan & Delivery Group decision

On 13th August the Delivery Group approved the Near Term Milestone Plan to achieve the milestones L104, L105, and L106 (Programme Plan Re-baseline, External Physical Interfaces Baselined, and Programme Parties Mobilised respectively).

The Near Term Plan was amended to take on board feedback from the Delivery Group, where it was noted that there had been insufficient time for industry consultation. The new delivery date for milestones L104, L105 and L106 is now set for 3rd October 2019. The extension of this deadline ensures that there is now time to elicit and address all comments.

The updates below are on how the necessary activities are tracking towards achieving the 3rd October delivery date.

Programme Plan Re-baseline

All constituencies meetings were completed last week, and the key themes that were raised in the meetings are set out in the Implementation Pack circulated 10 September.

Code of Connection progress

Comments on the Code of Connection have been received and the draft-final version has been created as of 28^{th} August. This was agreed without comment at the Design Forum today and is therefore on track for final approval at Design Authority on 20^{th} September.

Physical Interface Design Progress

Comments on the CSS and existing service provider interface specifications have been received and addressed. The final versions of these interfaces were agreed at the Design Forum this week with only a few small changes required to the CSS IS. The interface specifications are therefore on track for final approval and baselining at Design Authority on 20th September.

CSSIA progress

A product description was drafted by the SI/DCC and provided to Ofgem on 23rd August, ahead of a review meeting which went ahead on 28th August.

The consultation period has now closed as of 6th September. The SI are now reviewing comments and updating the CSSIA, and are due to present updates



at a workshop session on the 16th September. This workshop will cover how feedback has been addressed and what is coming in the final version, and will be split in to three sessions on Design, Data, and Testing.
