Upcoming Retail Energy Code consultations

We raised at the last Delivery Group meeting that there was a risk of the pre-General Election period restricting our ability to launch the upcoming planned regulatory consultations. We have now clarified that we are able to publish the planned consultations during this period. This means that we are progressing on consultations covering the Retail Code Consolidation Significant Code Review launch, the Retail Energy Code (REC) technical specification approach, and performance assurance/code manager service definitions content for REC v1.1 implementation. We expect publication of these documents around the end of November.

CSS simulator

The Systems Integrator (SI) has developed a CSS test simulator to be used by Switching Programme participants for Pre-Integration Testing (PIT). This became available to Programme licensed parties and existing service providers on the 23rd October.
