# **Readiness Assessment 010**

- On 10<sup>th</sup> December we issued v1.0 of the Switching Programme Readiness Assessment Framework, which will support the Programme in delivering against the future Readiness Assessment milestones in the overall Programme Plan.
- The next Readiness Assessment for Programme Participants, "RA010 Readiness Assessment 1 – Solution Delivery Checkpoint" will be active in the Switching Programme Web-Portal from 16<sup>th</sup> December and parties are asked to provide a response by 15<sup>th</sup> January. Responses will be collated to form a report to the Delivery Group on 4<sup>th</sup> February. Parties receiving a Readiness Assessment will include Licensed Parties, Existing Service Providers, Third Party IT Systems Providers, and Central Delivery Partners.

### **Cutover Working Group**

We are looking to stand up the Cutover Working Group as set out under our Governance Structure.

We are looking for membership of the Cutover Working Group to include representatives familiar with both current and enduring switching arrangements, together with experience of transition/implementation of both the system and business process changes.

The first meeting is due to be scheduled for January 2020.

## **End-to-end Customer Journey**

At the recent Delivery Group, it was agreed that suppliers would undertake a joint exercise to establish an inventory of business processes which might be impacted by Switching, in supplier organisations, to help suppliers plan for any required changes to their own business processes.

A pilot for this group is in the process of being established and a Chair appointed. At the Delivery Group it was noted that there was no change to the consumer journey in the context of non-domestic switches, and as such it was agreed to progress this as a domestic only matter. Once the Chair has been appointed then Ofgem will circulate further details about the timing of the pilot meeting.

#### **Price Comparison Website engagement**

At the Delivery Group meeting in November, Ofgem acknowledged there is a need to engage with Price Comparison Websites (PCWs) in relation to the Switching Programme. It was agreed at the Delivery Group to establish a joint Ofgem-supplier forum to engage with PCWs, and to assist in improving their awareness and understanding of the programme, as well as identifying options aimed at reducing delivery risk of these parties.

We are working through logistics for this forum and will announce details in our Web-Portal when available, and expect the forum to have its inaugural meeting mid-January 2020. ### **Data Migration Solution approval**

The Implementation Group have approved the Level 2 milestone (L2DA010 milestone (Design overall CSS Data migration solution). This represents a significant step forward and defines how the data migration from existing systems into CSS will take place. The design can be found <u>here</u>.



# **Retail Energy Code publications**

At the end of November, we published two sets of documents related to the development of the Retail Energy Code (REC),

- (1) the REC Technical Specification approach consultation; and
- (2) the Retail Code Consolidation Significant Code Review (SCR) launch statement.

The former publication opened the consultation on the REC Technical Specification approach documents. The REC Technical Specification will incorporate a data specification, security and data protection requirements, testing arrangements, and service definitions for each service specified by REC.

This consultation will close on 24th January, with a view towards consulting on the REC Technical Specification drafting in Spring 2020.

The Retail Code Consolidation SCR launch statement starts the SCR process to achieve retail code consolidation. To a large extent, this will be achieved through replacing the MRA in electricity and SPAA in gas, with the REC.
