Modification of National Grid Gas Plc's (NTS) Gas Transporter Licence to add a new National Transmission System (NTS) exit point

We¹ have decided to modify Part F of Special Condition 5G (Determination of Incremental Obligated Exit Capacity volumes and the appropriate revenue drivers to apply and the creation of Zero Licence Baseline Capacity Exit Points) of National Grid Gas Plc's (NTS) Gas Transporter Licence ("the Licence").² This modification was proposed in our statutory consultation published on 12 June 2020, to which we invited responses by 10 July 2020.3 The modification decision is published on our website alongside this letter. The changes, outlined below, will take effect from 12 September 2020.

The Modification

The modification will add one new NTS exit point to the Licence. We are adding "Saltholme Power Station" as a new exit point to Table 8: Licence Baseline Exit Capacity in Part F of Special Condition 5G which concerns Non-incremental Obligated Exit Capacity. A modified Table 8 is contained in Appendix 1 of the modification decision document.

Responses to our Statutory Consultation

We received one response to our statutory consultation from National Grid Gas Plc ("the Licensee"), which has been published on our website. The Licensee supported the proposed modification as outlined in the consultation, and confirmed that from when the proposed licence change will take effect, "Saltholme Power Station" NTS exit point will have no baseline capacity allocated, and as such its Enduring Flat Baseline quantity will be listed as zero. Following the statutory consultation, we have not made any changes to the Licence text we proposed in the statutory consultation.
