- Can you tell me about how you use data?
  - What do you use that data for? (is there a specific problem you're exploring?)
    - What will change once you have the data? What value does it add?
  - Where does the data come from? (is it public/private?)
  - Does it give you everything you need?

- Do you have to request the data?
  - How does that work?
  - Does it cost anything?
- Are there any pain points to getting that data? (barriers to access, data quality?)
- o Is there anything that could be done to make that any easier?
- How do you find your data?
  - Could you describe the process you go through?
  - o How do you know if you can trust the data and the source?
- Do you combine energy data with other sources?
  - Why do you do this?
  - Are there any challenges when doing this?
- Is there a specific format data needs to be in to make it easy for you to use?
  - O Why that format?
  - Does it come to you like that or do you have to do anything to make it that way?
- Do you provide any data back to the industry?
  - O How does that work?
  - o Are there any challenges to doing this?
- Do you use any services which make it easier to understand data from the energy industry?
  - For example, services that collate data?
  - For example, Enappsys?
  - Why do you use / not use services like this?
- Do you currently provide any feedback to organisations about their data that you use/how you're using their data?
  - O Why do you do this / not do this?
  - Can you think of any value in this?
- How would you feel if there was a shared standard for data across the industry?
  - Can you see any benefits to doing this?
  - Can you see any problems in implementing this?
- Do you have any thoughts about the overall benefits of data sharing?
  - Would it benefit yourself in any way?
  - How might it benefit other people?
- What costs do you perceive there would be to you?
  - Can you see any ways this could be mitigated?

- Are there any organisations that you view as influential in the energy industry?
  - O What makes them influential?
  - What are they influencing? (Positive change? Preventing change?)
- What's your understanding of what a data catalogue is?
  - How would you expect a data catalogue to work?
  - o In order for it to be useful to you, what would it need to have?
- Do you use or know of any data catalogues that contain information about the UK energy industry?
  - What data catalogues are you aware of?
  - O Why do you / don't you use them?
  - What would need to happen for them to be improved?
