### Electricity Act 1989 Section 11A(1)(b)

#### Modification of the Standard Conditions of all Electricity Transmission licences

- 1. Each of the licensees to whom this document is addressed ('the licensees') is the holder of an Electricity Transmission licence ('the Licence') granted or treated as granted under under 6(1)(b) of the Electricity Act 1989 ('the Act').
- 2. Under section 11A(2) of the Act the Gas and Electricity Markets Authority ('the Authority')¹ gave notice on 17 December 2020 ('the Notice') that we proposed to modify the Licence by:
  - a. amending the Standard Licence Conditions (SLCs) set out in Annex 1 of the notice;
  - b. inserting new SLCs set out in Annex 2 of the notice; and
  - c. removing existing SLCs set out in Annex 3 of the notice.

We stated that any representations to the modification proposal must be made on or before 19 January 2021.

- 3. A copy of the Notice was sent to the Secretary of State in accordance with section 11A(4)(b) of the Act, and we have not received a direction that the change should not be made.
- 4. We received 13 responses to the Notice, which we carefully considered. We have placed all non-confidential responses on our website. - 5. It is necessary to make a number of minor alterations to the modifications set out in the Notice. These alterations are shown in yellow highlight for the SLCs in the modification text that can be found at <a href="https://www.ofgem.gov.uk/publications-and-updates/decision-proposed-modifications-riio-2-transmission-gas-distribution-and-electricity-system-operator-licences">https://www.ofgem.gov.uk/publications-and-updates/decision-proposed-modifications-riio-2-transmission-gas-distribution-and-electricity-system-operator-licences</a>. The reasons for the differences between the modifications set out in the Notice and the modifications being made are to correct typographical, computational and arithmetical errors and to address minor issues and corrections raised since the issuing of the Notice.

  - b. RIIO-2 informal licence drafting consultation for Transmission, Gas Distribution and Electricity System Operator licences;<sup>3</sup>
  - c. RIIO-2 Draft determinations for Transmission and Gas Distribution companies and the Electricity System Operator;<sup>4</sup> and
  - d. RIIO-2 Final Determinations for Transmission and Gas Distribution companies and the Electricity System Operator.<sup>5</sup>
- 8. Where an application for permission to appeal our decision is made to the Competition and Markets Authority (CMA) under section 11C of the Act, Rule 5.7 of the Energy Licence Modification Appeals: Competition and Markets Authority Rules requires that the appellant must send to any relevant licence holders who are not parties to the appeal a non-sensitive notice setting out the matters required in Rule 5.2. The attached Annex 4 provides a list of the relevant licence holders in relation to this modification. Section 11A(10) of the Act sets out the meaning of 'relevant licence holder'.

Under the powers set out in section 11A(1)(b) of the Act, we hereby modify the Standard Conditions of the Electricity Transmission licence of the licensees in the manner specified at <a href="https://www.ofgem.gov.uk/publications-and-updates/decision-proposed-modifications-riio-2-transmission-gas-distribution-and-electricity-system-operator-licences">https://www.ofgem.gov.uk/publications-and-updates/decision-proposed-modifications-riio-2-transmission-gas-distribution-and-electricity-system-operator-licences</a>. This decision will take effect from 1 April 2021.
