Introduction



Extension applications

Non-TG NDRHI projects that are not expected to be commissioned before scheme closure on 31 March 2021 but can show that significant capital, human or material resource has been invested in project development on or before 17 August 2020 may make an **extension application** to secure extra time to join the scheme.

Extension applications, including **all** required information and evidence, (as outlined below) must be submitted on or after 1 March 2021 and before midnight on 31 March 2021.

If a properly made extension application meets the regulatory requirements and is approved by Ofgem, applicants will then have until 31 March 2022 in which to commission their plant and submit a properly made full application for accreditation. Applicants must also meet all the usual NDRHI scheme eligibility requirements when a full application in made.

Excluded Installations

As only Non-TG NDRHI plants are eligible for an extension application, the following technologies are excluded:

- Solid biomass CHP, geothermal and biomethane applications of all sizes
- Biomass greater than or equal to 1MWth
- Biogas greater than or equal to 600kWth
- Ground source and water source heat pumps (including Shared Ground Loops,[SGLs])
 greater than or equal to 100kWth

Extension applications may not be made in respect of a plant which is additional RHI capacity.

Information and evidence required

- Extension applications must be properly made and contain all the information and evidence specified in the guidance.
- One piece of primary evidence or two of the required pieces of secondary
 evidence will be considered sufficient to satisfy Ofgem that significant capital, or
 significant human or material resource has been invested in project development on
 or before 17 August 2020.
- Ofgem may, in granting an extension application, attach conditions.
- Ofgem may revoke the granting of an extension application at any time before the applicant applies for accreditation if the applicant fails to comply with any conditions imposed.

Important Information

Please read the following information before you proceed with your application:

- You can only submit extension applications on or after 01 March 2021 and before midnight at the end of 31 March 2021
- Extension applications cannot be amended
- To make a further extension application in relation to the same plant, you must first withdraw your original application

Please be advised that:

- You must be the designated Authorised Signatory of an account to manage an account, sign declarations associated to the account and to submit applications to Ofgem for review.
- Ofgem will require personal information relating to the Authorised Signatory of an account in order to verify their identity and assist in fraud prevention.
- To receive payments for accredited installations associated to an account, the
 Authorised Signatory must provide Ofgem with details for a valid bank account. This
 must be an account that can accept payments in the UK in pounds sterling. The
 Authorised Signatory must also agree for this information to be shared, by Ofgem in
 accordance with data protection legislation, with third parties in order to organise
 payment.
- Any applications that are created on an account and not submitted within 3 months (since the application was last saved) will be removed from system and you will not be able to retrieve them
