

Plan to Modify

Introduction

Before modifying the capacity of your shared ground loop system, you must first submit plans to Ofgem in line with the below guidance. Ofgem will then review these plans in accordance with The Renewable Heat Incentive Scheme Regulations 2018(as amended), before informing you whether your plan has been approved.

Please note that:

- This form must be completed by the Authorised Signatory.
- Ofgem must be notified of plan to modify capacity on or before 31st March 2023
- Our Guidance Volume 2: Ongoing obligations and payments and Easy Guide to Shared Ground Loops provides information on all plans to modify capacity
- Installation capacity must not be modified more than twice during the tariff lifetime for that installation.
- The tariff available for any newly added capacity will be in line with the existing installation, unless a tariff boundary is crossed.
- Additional heat pump(s) may only be used to provide space and/hot water heating.
- We cannot receive emails over 30MB, if you exceed the email maximum please distribute the documents over multiple emails.
- If further evidence is emailed to us, please save it in a compressed zip folder.


