Notice under Part E of Special Condition 3.10 (Visual Impact Mitigation Re-opener and Price Control Deliverable and Enhancing Pre-existing Infrastructure Projects allowance (VIMREt and EPIt)) of the Electricity Transmission Licence to add Enhancing Pre-existing Infrastructure Projects ("the Notice")

- Scottish Hydro Electric Transmission plc ("the Licensee") is the holder of an Electricity Transmission Licence granted or treated as granted under section 6(1)(b) of the Electricity Act 1989.
- 2. Special Condition (SC) 3.10.15 (Visual Impact Mitigation Re-opener and Price Control Deliverable and Enhancing Pre-existing Infrastructure Projects allowance (VIMREt and EPIt)) of the Electricity Transmission Licence specifies the circumstances in which the Gas and Electricity Markets Authority (the 'Authority')¹, by way of direction, can add the Enhancing Pre-existing Infrastructure Projects that the licensee has submitted to the Authority prior to the start of the Price Control Period and for which no Price Control Period allowance has been provided.
- 3. Part H of SC 3.10 sets out the process the Authority will follow making a direction under SC 3.10.15.
- 4. In accordance with SC 3.10.21 the Authority hereby gives notice to the Licensee and interested parties that it proposes to modify Appendix 3 of SC 3.10 in the manner indicated in Schedule 1 to this Notice.
- 5. We have set out our reasons for the modifications in our determination letter dated 30 April 2021 which is published alongside this Notice². In summary, the purpose of the modifications is to add the Killin mitigation project to Appendix 3, specify the deliverables of the Killin mitigation project that the Licensee is required to deliver, and to specify the associated EPI values.
- 6. We propose to further adjust the main contract price for changes in the metal price and exchange rate indices³ that have occurred in the period between the contractors submitting their final price, and the Licensee awarding the contract. We propose that this adjustment be reflected in the allowed expenditure that is directed following the 28-day notice period to implement our determination.
- The effect of the proposed modifications has been set out in our determination letter, which accompanies this Notice. In summary, the effect of these Electricity Transmission Licence modifications are to increase the Licensee's allowances under the RIIO-2 Electricity Transmission price control by £20.310 million (2018/19 prices).

- 9. We propose that the direction should take effect on 25 June 2021.
