## **Electricity Act 1989** Section 11A(1)(b)

## Modification of the Standard Conditions of all Electricity Transmission licences

- 1. Each of the licensees to whom this document is addressed ('the licensees') is the holder of an Electricity Transmission licence ('the Licence') granted or treated as granted under under 6(1)(b) of the Electricity Act 1989 ('the Act').
- 2. Under section 11A(2) of the Act the Gas and Electricity Markets Authority ('the Authority')1 gave notice on 14 April 2021 ('the Notice') that we proposed to modify the Licence by:
  - a. amending the Standard Licence Conditions (SLCs) set out in Annex 1 of the

We stated that any representations to the modification proposal must be made on or before 13 May 2021.

- 3. A copy of the Notice was sent to the Secretary of State in accordance with section 11A(4)(b) of the Act, and we have not received a direction that the change should not be made.
- 4. We received 9 responses to the Notice, which we carefully considered. We have placed all non-confidential responses on our website. Our response to these comments is set out at https://www.ofgem.gov.uk/publications-andupdates/decision-proposed-modifications-riio-2-transmission-gas-distribution-andelectricity-system-operator-licence-conditions. We have not made any changes to the SLCs as a result of these responses.

- c. RIIO-2 Draft determinations for Transmission and Gas Distribution companies and the Electricity System Operator;<sup>4</sup>
- d. RIIO-2 Final Determinations for Transmission and Gas Distribution companies and the Electricity System Operator;<sup>5</sup>
- e. Decision on the proposed modifications to the RIIO-2 Transmission, Gas Distribution and Electricity System Operator licences;<sup>6</sup> and
- f. Statutory consultation for the proposed modifications to the RIIO-2 Transmission, Gas Distribution and Electricity System Operator licence conditions.<sup>7</sup>
- 7. Where an application for permission to appeal our decision is made to the Competition and Markets Authority (CMA) under section 11C of the Act, Rule 5.7 of the Energy Licence Modification Appeals: Competition and Markets Authority Rules<sup>8</sup> requires that the appellant must send to any relevant licence holders who are not parties to the appeal a non-sensitive notice setting out the matters required in Rule 5.2. The attached Annex 2 provides a list of the relevant licence holders in relation to this modification. Section 11A(10) of the Act sets out the meaning of 'relevant licence holder'.

Under the powers set out in section 11A(1)(b) of the Act, we hereby modify the Standard Conditions of the Electricity Transmission licence of the licensees in the manner specified at <a href="https://www.ofgem.gov.uk/publications-and-updates/decision-proposed-modifications-riio-2-transmission-gas-distribution-and-electricity-system-operator-licence-conditions">https://www.ofgem.gov.uk/publications-and-updates/decision-proposed-modifications-riio-2-transmission-gas-distribution-and-electricity-system-operator-licence-conditions</a>.
