

To: **National Grid Electricity Transmission Plc SP Transmission Limited Scottish Hydro Electric Transmission Plc National Grid Electricity System Operator Limited**

Notice of statutory consultation on a proposal to modify the Special Conditions of the electricity transmission licence held by each of the above licensees

- 1. The Gas and Electricity Markets Authority ('the Authority') proposes to modify the electricity transmission licence held by each of the above licensees ("the licensees"), granted or treated as granted under 6(1)(b) of the Electricity Act 1989 by:
 - a. amending an existing Special Condition;
 - b. adding new Special Conditions; and
 - c. adding new definitions to Special Condition 1.1.
- 2. We are proposing these modifications to give effect to our decision in the RIIO-2 Final Determinations for to introduce a Strategic Innovation Fund.
- 3. Further detail on the reasons and effects of the proposed modifications, the full text of the modifications and a table setting out the new proposed definitions can be found on our website at https://www.ofgem.gov.uk/publications-and-updates/statutoryconsultation-licence-condition-changes-riio-2-strategic-innovation-fund, alternatively they are available from foi@ofgem.gov.uk.
