Dear Company Secretaries and stakeholders,

Proposal to make modifications to the Regulatory Instructions and Guidance

We propose to make changes to the Electricity Distribution Regulatory Instructions and Guidance (RIGs). These modifications are made for the purpose of clarifying the existing reporting requirements rather than introducing new requirements. Please find attached a Notice, issued pursuant to Part C of Standard Licence Condition 46, detailing our proposed changes.

If we implement these changes, they would take effect from 1 April 2016. For the avoidance of doubt, this means that the data submitted in July 2016 (in respect of the 2015/16 reporting year) would use the RIGs as modified.

We welcome comments on our proposed modifications, and the details for responding are contained in the attached Notice.

We also take this opportunity, following a request from a number of DNOs, to provide clarity on the question of when forecasting is currently required within the RIGs. There are three areas where the Licensees are required to provide forecast information:

- Table M16 'Forecasts' in Annex B Costs and Volumes
- Table F3 'Financing Requirements' in Annex C Financial Issues
- Tables E4 'Losses Snapshot' and E6 'Innovative Solutions' in Annex J Environment and Innovation

Notice under Part C of Standard Licence Condition 46 (Regulatory Instructions and Guidance) of the Electricity Distribution Licence of proposed modifications to the Regulatory Instructions and Guidance

- 1. Each of the companies to whom this Notice is addressed (each the "licensee") is the holder of an electricity distribution licence (the "licence") granted or treated as granted under section 6(1)(c) of the Electricity Act 1989.
- 2. The Gas and Electricity Markets Authority (the "Authority"¹) proposes to modify the Regulatory Instructions and Guidance (the "RIGs") under Standard Licence Condition ("SLC") 46 of the licence. The RIGs are the primary means by which the Authority directs the licensees to collect and provide information to the Authority, to enable it to administer the Charge Restriction Conditions (CRCs) of the licence and, where not referenced in the licence, the RIIO-ED1 Final Proposals².
- 3. Part C of SLC46 sets out the process for issuing and modifying the RIGs. In accordance with SLC 46.10, the Authority hereby gives notice to the licensees that it proposes to modify the RIGs in the manner indicated in Appendix 2 to this Notice.
- 4. The Authority proposes that these modifications should take effect on 1 April 2016.
- 5. The proposed modifications to the RIGs consist of new tables and revisions to existing tables. These modifications are made for the purpose of clarifying the existing reporting requirements rather than introducing new requirements. The purpose of the proposed modifications is to require the licensees to provide more accurate, consistent and complete information to the Authority, such as to enhance the quality and the accuracy of the information available to the Authority.
- 6. Further, we propose to introduce a new summary sheet in the RIGs. This sheet pulls together information on the licensee's performance under outputs, as well as general information such as customer network length. We propose that this sheet be published as part of the licensee's Business Plan Commitment Reporting under SLC 50. We are consulting on this change in parallel to these proposed changes to the RIGs.³
