## **Annex 1: SSE response to DCC Price Control Consultation: Regulatory Year 2014/15**

SSE supports Ofgem approach to assess the costs of DCC by:

- scrutinising the evidence DCC provided;
- conducting a cost visit and some benchmarking analysis;
- scrutinising future forecasts and proposing that DCC remove costs that are unlikely to be incurred, or where they have been found to not economic be and efficient.

We particularly welcome the undertaking of a forensic audit review of DCC's reporting, processes and procedures. To aid improvements in this approach, we propose a Lessons Learned review to provide input into further guidance and potential enhancements. We support the further expansion of DCC's benchmarking activities and we agree that this needs to be consistently applied.

The recommendations from the forensic audit review are strongly supported by SSE. We agree that for future procurements DCC should ensure it has sufficient detail on the evaluation process, in particular how cost and quality are assessed and weighted. This will be critical for procurement activities that DCC may undertake in the future, dependent on the outcome of current consultations.

We agree with the proposals set out to adjust DCC's total and forecasted Costs and we concur with the rationale provided, that these costs have not been sufficiently justified as economic and efficient. Whilst there has been improvement on the level of Industry engagement by DCC, we expect this to be enhanced further to ensure that there is consistency in the engagement approach across different activities, and that the engagement is timely and transparent to Industry on DCC's progress and costs.

SSE looks forward to engaging with Ofgem in early 2016 on the design of DCC's operational incentives.
