| The 2016 prequalification process has seen significant numbers of Applications fail to prequalify through the incorrect completion of Exhibits, including providing Exhibits that are dated for previous years. These Applications have subsequently needed to move through the Tier 1 disputes process to gain prequalification. The EMR Delivery Body provided guidance this year to confirm that Exhibits need to be signed contemporaneously with the Application, however this guidance was not heeded in all cases. This proposal to include the year in which the application is being made as part of the Exhibit will provide further clarity that these Exhibits are to be created and signed anew for each Application. | |

Prequalification process, this small change will result in an increase in the proportion of positive Prequalification Decisions and a corresponding reduction in Tier 1 disputes. Prequalification will be improved for those Applicants that do not then need to raise a dispute for an issue associated with incorrect dating of an Exhibit. The EMR Delivery Body will be able to focus its Tier 1 disputes resource towards those Applications that have more complex failure reasons. This change proposal looks to facilitate the efficient operation and administration of the Capacity Market.
