1.5. Meeting Minutes

Item1: Opening of PNDG meeting

- 1. Brett McGowan (PwC) opened the meeting with Nicola Garland (Ofgem) providing opening remarks noting:
 - The programme is continuing to focus on the three key milestones of IDR2, IDR3 and the end of Market Trial regression testing.
 - All Market Participants need to maintain their pace to ensure the milestone is achieved.
 - Xoserve held a 'Get ready' event on 13 Mar 17 which generated good discussion and was a useful starting point for the development of Post-Go Live governance, which will now go through a process of consultation with the industry.

Item2: Approval of PNDG minutes

2. No comments or questions were received on the 28 Feb 17 set of meeting minutes, however Melisa Findlay (PwC) noted that action A241 was not required and will be removed from the final version of the minutes. These were taken as approved and will be posted on the Ofgem website:

Item3: Review of the Current PNDG Report

PNDG Report covering the period 24 Feb 17 – 09 Mar 17

- 3. Brett McGowan provided an overview of the Programme Status Report (slide 3) noting;
 - The Programme remains Amber in recognition of the level of risk across each of the workstreams and proximity of Go Live.
 - Solution Delivery remains as Amber due to the on-going requirement for confirmation of data volumes post Go Live.
 - Market Trials has deteriorated to Amber due to the number of Market Participants who were due to have completed testing but have not yet done so.
 - Data remains Amber due to In Flights and the on-going issue of inconsistency between iGT, Shipper and Xoserve data.
 - Transition remains Amber largely due to the level of work load and dependency of IDR2 on In Flight testing.
 - GONG remains Green/Amber as a result of several of the issues faced by other workstreams and the maturity of Market Participants Transition planning.

- 4. Steve Nunnington (Xoserve) presented the Solution Delivery Status Report (slide 4), noting;
 - All the milestones are complete however the issue regarding Post Go Live volumes is still outstanding. Xoserve are setting up a meeting to progress this issue further.

- 5. Melisa Findlay (PwC) presented the Market Trials POAP supported by Richard Shilton (PwC) presenting the wider workstream (slides 5-10) noting;
 - There are two open milestones; 'MT 2.6 Regression Complete' which is currently behind schedule and rated as Amber, and 'MT 2.7 Standard Regression Test Pack Agreed'.
 - Matt Adams (Baringa) confirmed that the Regression Test Pack is complete and that Baringa will provide an assurance report to PNSG on the maintenance of code stability during Market Trials Regression.
 - MT Regression test completion is behind the forecasted test completion rates, however most Market Participants are still reporting they are on track to complete before 24 Mar 17. Attendees were asked if there are key blockers constraining completion. These were categorised as;
 - Outstanding issues on defects and reconciliation of catch up files which are due to complete in the next couple of days. There is still testing required to gain confidence in the IDL files.
 - An attendee commented that they would have more confidence if they knew there was space to test fixes in Post Go Live environment rather than putting operations at risk. Nicola Garland (Ofgem) responded that it may be possible to take a skeleton plan of a Post Go Live workstream, including milestones such as defects and environments, to either the next PNSG on 22 Mar 17 or the next PNDG.
 - Invoicing files are recognised as a potential blocker for some market participants, however this work is on-going.
 - A defect workshop was held on 09 Mar 17 to go through P3 defects and confirm that these defects are appropriate for deployment Post-Go Live.
 - All but a few of the defects discussed at the workshop were agreed to be deployed Post-Go Live and were assigned a status of High/Medium/Low, in order to assist the planning of defect deployment.
 - The workshop was successful in building confidence in P3 defects. The final list of defects will be agreed through weekly defect meeting.
 - Market Participants were reminded that if there is a requirement to test beyond 24 Mar 17, then non-critical tests are to be de-scoped to avoid the use of contingency and inform their PwC/Ofgem account manager.

Question from PNDG Attendee:	Response:
2. Will there be an opportunity to retest fixes?	If it is not possible to retest fixes in the time available then Market Participants are to make their account manager aware.
3. Will a test environment be available immediately after Go Live?	Yes, Xoserve have committed to providing an environment and more detail will be provided at the next PNDG.

6. Melisa Findlay presented the Data POAP supported by Steve Nunnington presenting the wider workstream (slides 11 -14) noting;

- As discussed at the last PNDG, milestones 'D1.1 Pre IDR2 US Data load testing complete', 'D1.2 Pre IDR2 iGT Data load testing complete' and 'D1.5 Pre IDR2 In Flight transaction testing complete' were running beyond the milestone dates to 13 Mar 17 to enable further testing. D1.1 is now complete and D1.2 is due for completion on 15 Mar 17.
- 'D1.6 Pre IDR3 In Flight transaction testing complete' is a new milestone which was approved at the last PNSG meeting. This has been included in the new version of the POAP.
- IDR2 is progressing well, with only 7 defects raised. IDR2 now moves into the NED phase.
- Milestone 'D3.4 iGT data reconciliation' is currently Amber/Red, however the mini-DMG held on 8 Mar 17 was successful in bring it towards a close.
- 'D3.5 T-Rule non-compliance plan' complete has been realised noting that defect have reduced below 2k and continuing to fall, this milestone will now be marked as closed.
- The data workstream is Amber overall. There are some minor defects with the delta load in IDR2 which affect very few sites. Some defects from In Flights will be taken into IDR3.
- Data load shows continued good progress, In Flights and data inconsistencies remain the focus.

Question from PNDG Attendee:	Response:
4. The Baringa report states that some high priority scenarios have slipped. Is there potential for a further In Flight test cycle?	This is not directly related, some high priority scenarios slipped but not past the date required. These will be delivered in the required timeframe. It is a recommendation of Baringa in the entry to IDR2 report that further Test Cycles are conducted to address defects.

- 7. Melisa Findlay presented the Transition POAP supported by Philip Russ (PwC) presenting the wider workstream (slides 15 -16) noting;
 - The IDR2 and IDR3 completion milestones remain Amber due to proximity. This RAG status does not reflect the progress of the IDR2 which is being communicated through daily reporting to TPG.
 - Xoserve's analysis has confirmed that the three organisations which will cutover early can be accommodated. If there are any changes to cutover dates from here on in, organisations will have to go through a formal change request process to seek approval from Ofgem.
 - IDR2 progress is tracking as Green. All activities are completing on plan. Of 30 data defects, 21 have already been resolved, two were rejected and seven were parked.
 - IDR2 is entering the first NED day today (14 Mar 17).
 - The contingency playbook is currently out for review with TPG member. It will be brought to the next PNDG for sign off.
 - IDRO exit report is due to be issued 17 Mar 17 for review.
 - TPG will consider cutover structure for Market Participants.

Question from PNDG Attendee:	Response:
5. In respect to reporting, there was a previous commitment that Market Participants would be provided with a report around Data and fall out. Is this the same as the cut over reporting that is being outlined?	These are two different reports. The Fallout reporting details the 'Data Defects', 'Functional Defects' and 'Non-Functional Defects' at the conclusion of IDR2, IDR3 and Cutover. Another report is being developed to detail the progress each Market Participant is making through cutover. A dashboard approach is being considered.

- 8. Melisa Findlay presented the GONG POAP supported by Martin Crozier (PwC) presenting the wider workstream (slides 17 -20) noting;
 - The remaining milestones are tracking Amber/Green to reflect the most recent portal submissions. The next portal submission is due 16 Mar 17.

- There has been a good response on portal, 35 submissions were received, 62 % of these are reported as Green.
- There are five key areas of concern; iGT data alignment, In Flights, maturity of Market Participants' plans, Post Go Live support and governance and completion of Market Trials Regression tests.
- In Flights is being monitored closely and work is on-going to support Market Participants to address questions as they arise.
- 11 GONG site visits have been completed and a further 12 are planned.
- Work is starting on the assurance report for G2.
- Market Participants were requested to report any issues or areas where support is required and to provide evidence to support rag status for G2.
- The Go Live Governance plan has been presented to several forums and will be made available to PNDG and PNSG members later this week.
- 9. Matt Adams (Baringa) presented Xoserve's G2 Status Summary (slide 21) noting;
 - Non-functional testing has stayed Amber.
 - Business process documentation is lagging behind plan, but is not Go Live critical
 - Post-Go Live governance is Amber.

Item4: RAID Update

- 9. Nicola Garland (Ofgem) provided an update on Risks, Issues and Actions (Slides 22 28) noting;
 - A231 It was agreed that the due date should be changed to 17 Mar 17 to align with the end of IDR2.
 - A232 Agreed that due date would be extended.
 - A240 Steve Nunnington confirmed that Xoserve will provide some CMS training and they are currently arranging the logistics. The action will remain open until the training has concluded.
