### Letter of Authorisation

#### What is it?

It's a letter we need from organisations applying for Domestic RHI accreditation or investor registration on the Domestic RHI, where the RHI payments will be made into the organisation bank account. It tells us who is nominated as the Authorised Representative of the organisation, applying for the Domestic RHI. Details are below and a template you can use for the Letter of Authorisation is overleaf.

#### Why is it required?

We require confirmation that the person applying for the Domestic RHI is authorised by their organisation to accept payments into a given bank account. Without the completed Letter of Authorisation, organisations won't be able to join the scheme.

#### Who completes it?

The person filling out and signing the letter must be a signatory on the organisation's bank account.

#### Do I need one per application?

No. If you are a landlord planning to submit many applications paid into the same organisation's bank account, you can choose for the Letter of Authorisation to cover all subsequent applications. If you are an investor, once successfully registered, this form can cover any subsequent nominations.
