1. Context

- 1.1 The next round of RIIO price controls will run from 1 April 2021 31 March 2026 for the Electricity Transmission ("RIIO-ET2"), Gas Distribution ("RIIO-GD2") and Gas Transmission ("RIIO-GT2") sectors. For Electricity Distribution ("RIIO-ED2"), the next price control will run from 1 April 2023 31 March 2028. The price control setting process by Ofgem has commenced for RIIO- ET2, RIIO-GD2 and RIIO-GT2. Ofgem are also developing a new price control for the Electricity System Operator (ESO), which will apply from April 2021.
- 1.2 To strengthen the voice of consumers in the process of setting price controls for energy network companies, Ofgem have established the RIIO-2 Challenge Group ("the Group") for all RIIO-2 price controls¹.
- 1.3 This document sets out the priorities and work plan of the Group for RIIO-ET2, RIIO-GT-2, RIIO-GD-2 and ESO.

2. Summary of the activities of the Group to date

2.1 The Group was established in 2018 with an introductory meeting with Ofgem taking place in August. The table below summarises the activities of the Group since its inception.

3. Priorities

- 3.1 Following the introductory meetings of the Group with Ofgem, Chairs of the Customer Engagement Groups, User Groups and network companies and Ofgem's publication of sector the specific methodology consultation in December 2018, the Group met in January 2019 to discuss its priorities and forward work plan.
- 3.2 In line with the objective and primary purpose of the Group, as stated in its terms of reference, the Group has agreed that it will focus its scrutiny of business plans of the companies for RIIO-2 on the following areas (in no particular order of importance and including but not limited to):

- a. Enhanced engagement
- b. Outputs and incentives²
- c. Costs³
- d. Finance, including financeability and risk
- e. Enabling competition
- f. Energy transition, including whole system and decarbonisation
- g. Innovation
- h. Deliverability of plans including competency, commitment and culture.
- 3.3 The Group and the Chairs of the Customer Engagement Groups and User Groups have arranged regular contact in order to ensure appropriate coordination and coherence between their respective activities.

4. Expectations for the draft RIIO-2 business plans

- 4.1 Ofgem require network companies to submit a first draft of their RIIO-2 business plan to the Group on 1 July 2019 and a second draft of their business plan to the Group on 1 October 2019 before the final plans are submitted to Ofgem in December 2019.
- 4.2 Ofgem have said that they will take into account the report produced by the Group on the assessment of the plans⁴. Ofgem have also said that they will take account of the quality and timeliness of engagement and submission of information. At each business plan submission stage (including preliminary information), the Group will assess the value for money, quality and deliverability of the plans provided by the companies before submitting its final report to Ofgem in December 2019.
- 4.3 The draft plans submitted to the Group on 1 July and 1 October 2019:
 - a. must follow the most up to date Business Plan Guidance issued by Ofgem.
 - b. must be complete. Where any information is not provided, there must be a clear explanation as to why it is missing and when it will become available.
 - c. must include complete business plan data templates and supporting documentation, in a scope and format agreed with Ofgem. Where any information is not provided, there must be a clear explanation as to why it is missing and when it will become available. The data should also indicate the degree of certainty associated with it, i.e. whether the prices are firm or estimates and degree of assurance. A clear explanations of change from previously submitted information should be provided.
- 4.4 In addition, for the 1 October 2019 submission, network companies:

- a. must clearly set out in respect of each section of the plan where a Customer Engagement Group or User Group agrees or disagrees with proposals (and why).
- b. must set out in a summary table material changes from the previous plan with reference to page numbers. A clear explanations of change from previously submitted information should be provided.
- c. should provide a summary of what has been amended (or not amended) in response to the feedback received from the Group on 1 July 2019 business plan (or any changes otherwise made).
- 4.5 The drafts plans will not be published by the Challenge Group at any stage.

5. Work plan

5.1 The forward work plan of the Group (until December 2019) is summarised in table 2 below.
