# Latest news

## **REC v1.0 designation and licence modifications**

On February 1st, the Retail Energy Code (the REC) version 1.0 was designated. The REC is a new dual fuel industry code, which is in due course intended to cover all retail requirements.

Companies holding a Gas Supplier, Electricity Supplier, Gas Transporter, Electricity Distribution or Smart Communications licence are required to accede to and comply with the REC.

The accession agreement, along with more information on the REC designation and accession process, can be found <u>here</u>. Accession agreements will need to be returned before Thursday 28<sup>th</sup> February, on which date the REC will take effect.

In addition to the obligations to accede to and comply with the REC, we have also introduced a duty on all licensees to cooperate with the Authority in order to ensure the effective delivery of a Significant Code Review (SCR). This will include the current Switching Programme. This will provide the basis for ensuring that key market participants will operate in line with the Switching Programme plan and milestones. We intend to revise our current guidance on the SCR process to include more detail on the practical application of the new Duty to Cooperate.

We published the <u>REC 2019/20 Budget consultation</u> in January. Responses to the consultation are to be sent to <u>switchingprogramme@ofgem.gov.uk</u> and are due before Friday 15<sup>th</sup> February. Following parties accession to the REC, RECCo will be issuing invoices early March, for payment before the end of March.

## **Programme Coordinator announcement**

In our last issue we set out that we had awarded the contract for the Programme Coordinator function to our preferred bidder. We are now able to announce that we have awarded the contract to PwC. PwC will provide the Programme with a PMO function, industry coordination, advice to the Programme Senior Responsible Officer (SRO) and Programme Assurance.

We have been busy in January on boarding PwC to the Programme. Many of the faces that have joined us have previous experience working with Ofgem and bring a wealth of knowledge working on large industry change programmes.

# What's coming up

## **DBT entry preparations**

Ahead of entry in to the Design, Build and Test (DBT) phase, the Programme SRO will be making a decision on whether to proceed to DBT. The framework for this decision will be the DBT readiness framework, which the Programme Coordinator is currently preparing. It is Ofgem's intention that this will be discussed with Programme Participants in the coming weeks.



In addition to this, the Programme team is working through information received from our recent RFIs to existing system providers, and service procurement developments, to feed in to the Final Business Case (FBC) and decision.

The DCC are progressing well on the procurements ahead of entry in to DBT, with the DCC expecting to enter in to contract with the Systems Integrator in February. The DBT entry point in April 2019 is aligned with point of contract signature for the Central Switching Service (CSS) provider, which is also on track.

The FBC, outlining the decision, will be published externally in Q1 2019.

# Mobilisation Survey – insights and next steps

We have had a good response rate so far from our stakeholders to our first Switching Programme Mobilisation survey. Some of the themes and suggestions that we have taken from this exercise:

- Programme participants would welcome a plan that sets out the activities required of them that are specific to their business activities only;
  - We are looking to gain further insights on planning at the Programme Coordinator launch event being held in London and Birmingham in February
- Some Programme participants had views that internal planning activity would commence at the point of the physical CSS design baseline;
  - We would like to note that our expectations are that industry are ready to mobilise in accordance with the DBT plan
- Some suggestion of irrelevance of the Switching Programme in the case of nondomestic suppliers
  - To reiterate, as set out in our logical design, the Switching arrangements apply both to domestic and non-domestic switches, with different requirements specific to non-domestic switches.

With the Programme Coordinator now on board and preparing for industry coordination events and communications, the above comments will be addressed in their key messaging.
