Dear Company Secretaries and stakeholders,

Proposal to modify the Regulatory Instructions and Guidance (RIGS) for RIIO-ED1

We propose to modify the Regulatory Instructions and Guidance (RIGs) for RIIO-ED1. Please find enclosed a Notice, issued pursuant to Part C of Standard Condition 46 (Regulatory Instructions and Guidance) of the Electricity Distribution Licence, in respect of our proposed modifications.

These modifications are made for the purpose of collecting additional information, clarifying the existing reporting requirements on the licensees and providing greater insight into the performance under RIIO-ED1.

With regards to Annex F – Interruptions, we will be consulting separately on changes to Chapter 3 (Guidance on the guaranteed standards of performance), as well as the corresponding template (guaranteed standards of performance reporting pack). The separate consultation will only apply to the guaranteed standards element of Annex F. Proposed changes to the other parts of Annex F are included in this consultation.

Unless otherwise stated in the RIGs, we propose that if we implement these changes, they will take effect in April 2020. For the avoidance of doubt, this means that the data submitted in respect of the 2019/20 reporting year would use the RIGs as modified.

We welcome comments on our proposed modifications, and the details for responding are contained in the enclosed Notice.

Notice under Part C of Standard Licence Condition 46 (Regulatory Instructions and Guidance) ("SLC 46") of the Electricity Distribution Licence of proposed modifications to the Regulatory Instructions and Guidance for RIIO-ED1

The Gas and Electricity Markets Authority (the "Authority"¹) hereby gives notice in accordance with paragraph 10 of SLC 46.

Proposal to modify the Regulatory Instructions and Guidance

- 1. Each Licensee is the holder of an electricity distribution licence (the "Licence") granted or treated as granted under section 6(1)(c) of the Electricity Act 1989.
- 2. The Authority proposes to modify the Regulatory Instructions and Guidance (the "RIGs") under SLC 46 of the Licence.
- 3. The proposed modifications make changes to:
 - (a) RIIO-ED1 Electricity Distribution Price Control Regulatory Instructions and Guidance.
 - (b) RIIO-ED1 Electricity Distribution Reporting Pack Templates.
 - (c) RIIO-ED1 Electricity Distribution Commentary.

Appendix 1 to this Notice provides a link to these documents, which show the proposed modifications as incorporated.

- 4. The proposed modifications to the RIGs consist of revisions to existing guidance, new tables, revisions to existing tables, new commentary, removal of commentary, and revisions to existing commentary. Appendix 2 to this Notice provides a link to an Issues Log, which details the various proposed modifications.
- 5. The purpose of the proposed modifications is to collect additional information, clarify the existing reporting requirements on the Licensees, and provide greater insight into their performance under RIIO-ED1. The effect of the proposed modifications would be to require the licensees to provide more accurate, consistent and complete

information to the Authority to enhance the quality and the accuracy of the information available to the Authority.
