

## **Notice of Statutory Consultation**

#### To: Holders of an Electricity Transmission licence or Distribution Network Operators Licence.

#### Electricity Act 1989 Section 11A(2)

# Notice of statutory consultation on a proposal to modify the standard conditions of on shore electricity network operators licences.

- The Gas and Electricity Markets Authority ('the Authority') proposes to modify the standard conditions of the Electricity Transmission licence (Section D: Transmission Owner Standard Conditions), and The Distribution Network Operators Licence granted, or treated as granted, under section 6(1)(b) or 6(1)(c) of the Electricity Act 1989 by introducing new standard licence condition (SLC [D17]~[7A] – Requirement to coordinate and cooperate in planning and operating the electricity network). The proposed licence condition clarifies the expectations placed on Electricity Distributors and transmission owners under Section 9 of the Electricity Act 1989. Annex 1 includes the proposed text for new electricity transmission SLC D17 and Annex 2 includes the proposed legal text for new electricity distribution SLC 7A.
- 2. The proposed licence condition sets an obligation on Electricity Distributors and transmission owners to coordinate with other Electricity Distributors and transmission licensees and cooperate in order to build a common understanding of where actions taken by one Electricity Distributor or transmission owner could have cross-network impacts. In additional, it requires Electricity Distributors and transmission owners to consider actions proposed by network users that seek to advance the efficient and economical operation of its own network. Where actions and processes identified do not negatively affect Electricity Distributors and transmission owners networks', and are in the interests of the efficient and economical operation of the electricity Distributors and transmission owners should use all reasonable endeavours to implement them.

- 3. The proposed licence condition requires that Electricity Distributors and transmission owners publish a Coordination Register at least every twelve months demonstrating the steps it has taken to undertake whole electricity systems actions and processes. This will include information on proposals brought forwards by electricity network users, and will inform stakeholders on the actions that the Electricity Distributors and transmission owners are taking to realise whole electricity system outcomes.
- 4. We are proposing this modification to ensure that the most beneficial planning, investment, and operational actions are identified, resulting in more efficient and economical operation of the GB electricity network as a whole.

## **Introduction**

This should include at<br/>a minimum sharing information and developing processes that aim to<br/>achieve optimal efficiency across the total system. The further purpose is<br/>to set an obligation on transmission system users that seek to advance the<br/>efficient and economical operation of its own network.
